The decision to impose/withdraw restrictions is reviewed regularly on the advice of concerned Administrative Ministries on consideration like:

- ((i) Availability of sufficient installed capacity for a product *vis-a-vis* the demand situation;
- (ii) Availability of raw materials *vis-a-vis* the requirements from the industry;
- (iii) Manufacturing process resulting in Pollution;
- (iv) Items requiring control from ecological, safety and hazard angle.

(d) and (e) Except for items referred to in parts (a), (b) and (d) above, there is no restriction on manufacture of any item in small scale sector. Registration is optional but units are encouraged to register themselves with District Industries Centre to facilitate delivery of incentives and inputs.
