- WAN): (a) and (b) An amount of Rs. 27. 43 crores is outstanding from the Government of Libya for projects executed by the IAAI.
- (c) and (d) The matter is being pursued consistently with the Government -of Libya through the Indian Embassy in Libya. However, despite assurances given by the Libyan authorities, the outstanding dues have not been settled as yet.

Youth COUDCH for evolving the National Youth Policy

- (i) Suggest policy measures and programmes for youth;
- (ii) Advise the Government on measures for the implementation of the Plan of Action of the National Youth Policy;

- rfiii) Review the co-ordination betvarious Departments of the Central/State Governments and all Voluntary Organis. itions/other Agencies involved therein; and
- (iv) Provide a feed-back on the implementation of the National Youth Programmes.

The Council have 221 members with the Prime Minister as its Chairman.

(c) A National Youth Policy is being formulated.

Setting up of Coal Company in Orissa
