CM Raids conducted on the Premises of Development Commissioners, iron and Steel

(a) whether it is a fact that the Central Bureau of Investigation has conducted raids at the office/residential premises of Development Commissioners, Iron and *Steel*, Delhi and Bombay recently;

(b) whether it is also a fact that a large number of complaints of harassment of

traders by these officers have been received during the last one year; and

(c) what steps are being taken against such officials?

THE MINISTER OF STATE IN TUB MINISTRY OF STEEL AND MINES (SHRI BASAVARAJ PATIL); (a) The Central Bureau of Investigation conducted simultaneous searches of the office as well as residential premises of Regional Development Commissioner for Iron and Steel, New Delhi, in August, 1990.

There is no report of any raid at the office/residence of the Regional Development Commissioner for Iron & Steel, Bombay.

(b) Some complaints have been received in this Department concerning the Regional Development Commissioners. The complaints have not been substantiated Several of them are pseudonymous complaints.

(c) CBI has registered a regular case against the Regional Development Commissioner for Iron & Steel, New Delhi foi possession of assets disproportionate to the known sources of his income.
