THE MINISTER OF RAILWAYS (SHRI JANESHWAR MISHRA): (a) Yes, Sir.

(b) There was apprehension of leakage of question paper. It was, therefore, decided to hold a fresh written examination.

- (c) No, Sir.

(f) No, Sir. Railway Recruitment Board, Madras challenged the decision of the single judge in writ appeal before the Division Bench of the High Court Madras High Court gave a verdict in January, 1990 that Central Administrative Tribunal, Mardas, which upheld the decision to hold the fresh written examination, had no jurisdiction in this case as the candidates were not yet railway employees.

(g) and (h) Since there was a conflict between the views of Central Administrative Tribunal, Madras, which upheld the decision to hold fresh written test, and High Court, in regard to jurisdiction in recruitment matters, a Special Leave Petition has been filed by Railway Recruitment Board, Madras in Supreme Court on 5-4-1990 for a specific ruling on the subject. As the case is subjudice, it would not be possible to take further action in the matter of selection.

(b) and (c) All the three applica-w tions of M/s. IPICOL, Orissa have been rejected finally.

## Construction of Talcher-Gopalpur Railway Line, Orissa

1019. SHRI KAHNU CHARAN LENKA: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that the Orissa Government has submitted \* proposal to the Central Government for construction of Talcher-Gopalpur railway line for transportation of coal from Talcher coal field to power houses of South India through Gopal-pur minor port;

(b) if so, whether Central Government have accepted the same; and

(c) if so, by what time it is likely to be implemented?

THE MINISTER OF RAILWAYS (SHRI JANESHWAR MISHRA): (a) to (c) The Chief Minister of Orissa had suggested in May, 1990, that instead of doubling of Talcher-Cut-tack-Paradip railway line, a new railway line from Talcher to Berhampur with extension to Gopalpur Port should be investigated.

Accordingly the Railway was advised to carry out a quick Reappraisal Survey. The Railway has advised that the operational cost for the Tal- cher-Berhampur-Gopalpur Port line will be more than Rs. 500 crores and it involves construction of 20 major bridges including one over Mahanadi > spanning about 2 km. and 2 tunnels of total length of 13 km. aPprox. The proposed alignment does not take into consideration the reserve coal belt areas and th<sub>e</sub> operational cost will be exorbitant and additional station staff would be required to man new stations. In view of the **fact** that the survey for the doubling between Cuttack and Paradip Port is already in progress and the construction work on path doubling between Talcher and Rajatgarh is also in progress and a BG rail link from Sambalpur to Talcher is also under consideration, it is considered that the proposal does not seem to be an economic proposition as corresponding capacity can be generated by utilising the existing trunk route with lesser investment. However, the Railway has been recently advised to update the survey.

# Running of a super fast train between Delhi and Bhubaneswar

1020. SHRI KAHNU CHARAN LENKA: Will the Minister of RAIL WAYS be pleased to state:

(a) whether Government propose to start a super fast train between Delhi and Bhubaneswar to reduce the rush in this route; and,

(b) if so, the time by which it would be introduced?

THE MINISTER OF RAILWAYS (SHRI JANESHWAR MISHRA) j (a) There is no proposal at present to introduce any additional train between Delhi and Bhubaneswar. Efforts are however on to speed up Neelachal Express.

. (c) if so, the details of the enlisted suppliers as on the 31st December,

1990 and also those who do not manufacture directly any one of the critical equipment;

(d) whether the National Level Standing Committee of National Co operative Development Corporation has granted exemption to certain firms for such manufacture of any critical item; and

(e) if so, the names of such firms?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JAYANTILAL VIRCHAND-BHAI SHAH): (a) The National Cooperative Development Corporation (NGDC) based on the recommendations of the National level Standing Committee maintains the list of suppliers of turn-key sugar plants. The list of suppliers as prevalent before the constitution of the present Standing Committee has been adopted as it is by the Committee at the national level after its constitution, and thereafter three additional suppliers have been enlisted on the merits of each case and on the basis of the main criteria that the firm should be an approved supplier of atleast one of the critical equipments.

(b) Yes, Sir.

(c) The lists are at Statement-I and II respectively. However, the names of the firms at Annexure II were in the list before the National Level Standing Committee was constituted. (See below).

(d) No, Sir.

(e) Does not arise.
