VIRCHAND-BHAI SHAH): (a) The Committee, constituted under Chairmanship of Shri Bhanu Pratap Singh to go into the issues relating to declaring Agriculture as an Industry, has made certain observations in its Report on the methodology followed by the Commission for Agricultural Costs and Prices in recommending Procurement/minimum prices for various crops.

- (b) Committee has not agreed with the methodology- followed by CACP recommending procurement/mini mum support prices of crops. It has recommended that support price of farm products be linked to parity determined according to Prin price, Parity, with ciple of base year 1970-71---180.

DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI RAM BAHADUR'SINGH): (a) During the International Drinking Water Supply and Sanitation Decade (IDWSSD), 192, 024 problem villages were covered in the Sixth Plan and 153, 390 problem villages in the Seventh Plan with safe drinking water facilities. As on 1. 4. 1990, there were 8332 problem villages which have spilled over to VIII Plan. Out of these, 5170 problem villages are likely to be covered in 1990-91.

(b) the expenditure incurred under the State Sector Minimum Needs Programme and Centrally Sponsored Accelerated Rural Water Supply Programme during the Sixth Plan and the Seventh Plan and in 1990-91 so far is given in the Annexure. (See Appendix CLVI, Annexure No. 29)
