THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SMT. USHA SINGH); (a) and (b) ITDC has its own Recruitment Promotion and Seniority Rules and the appointments/promotions'transfers are regulated in accordance with the provisions contained therein. Relaxation as permissible under these Rules with regard to educational qualifications, age, experience etc. are given wherever required with the approval of the competent authority as defined. Training to employees in ITDC is need based and sponsoring is on the baste of nominations made by the Heads of Divisions/Units.

Governor of Delhi Rule 41-A of the Delhi Cooperative Societies Rules, 1973 was promulgated by the Lt. Governor vide notification dated 2. 11. 90 in exercise of the powers conferred upon him by sub-Section (1) of Section 97 of the Delhi Cooperative Societies Act, 1972. The rule provides that a vacancy in membership occuring between the period of verification by the Registrar of Cooperative Societies and allotment of land by the Delhi Development Authority shall not be filled by the society and envisages that a vacancy arising after allotment of land may be filled only from

among the willing registrants for DDA fiats under Self Financing Scheme.
