The Central Government has advised the State Govern-ments/U. T. Administrations from time to time among other things, (i) to increase the coverage of population by opening of new Fair Price Shops (FPS) or using mobile vans in the areas which are unserved or under-served; (ii) to increase the commodity coverage; (iii) to evolve an effective coordination system among various agencies engaged in PDS; (iv) to organise sale of PDS items in haats in Tribal areas; (v) to set up advisory/Vigilance Committees at various levels; (vi) to monitor the availability of PDS items to consumers at field levels and (vii) to enforce strictly the provisions Of Essential Commodities Act and similar other legislation to curb malpractices

(e) Provision of essential commodities to the entire country through PDs at more or less stable prices has a significantly antiinflationary effect.
