Rehabilitation plans for units of HFC

1118 SHRI SURESH PACHOURI: Will the Minister of AGRICULTURE be pleased to state;

(a) whether Government had rejected the Rs. 600 crores rehabilitation plans for 3 units, of the public, sector HFC limited;

(b) if so, what were the reasons therefor;

(c) whether Government had asked to reduce the plan, and

(d) if so, to what extent; and whether Government propose to review the HFC units?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI RAM BAHADUR SINGH): (a) to (d) As recommended by the consultants, Hindustan Fertilizer Corporation had submitted a plan for revamping the operating units of HFC (except Namrup-III) at estimated cost of Rs. 486 crores, which was updated to Rs. 604 crores in February, 1990. This has not been rejected; however, in view of the high investment involved

(including adhoc allocation of 10, 000 tonnes for festival season.

constraint of resources, and the fact that technologically the plants cannot be upgraded, Government asked HFC for alternative plans involving reduced outlay. No final decision has been taken on the various proposals.
