However, the International Airports Authority of India had conducted a traffic survey of six domestic airports in 1985 and 1986 to assess their potential for operation of international services. ## Use of dangerous Contraceptives .

1278. SHRI V. GOPALSAMY: SHRI R. GANESAN alias MISA R. GANESAN;

- (a) whether incidents of use of hazardous contraceptives have been brought to the notice of Government,
- (b) whether any study has since been conducted in this regard, if so, what are the details thereof; and

THE MINISTER OF HEALTH AND FAMILY WELFARE (PROF. SHAKE-ELUR REHMAN). (a) None of the contraceptives being used in the National Family Welfare Programme (viz. Sterilisation Vasectomy/Tubectomy|Laparoscopy, Cu.T 200 N, Oral Pills and Condoms etc.) are hazardous.

- (b) The Indian Council of Medical Research have undertaken studies on the newer generation of IUDs, subdermal implants, injectables, Tri-phasic pills, and none of these methods were observed to be hazardous.

THE MINISTER OF STATE RE-THE MINISTRY OF HUMAN DEVELOPMENT (SHRI SOURCE BHAGEY GOBARDHAN) (a) to (c) Selection Scale to the teachers in pursuance of orders dated 27 3 1990 of 🛚 Delh<sub>1</sub> Administration could not be granted by the Delhi Administration, pending consideration of the demand of teachers to grant Selection Scale straight-way to those who have rendered 24 years of service. This demand is under consideration of Government. The Selection Scale shall be granted to the teachers as soon as a policy decision is taken by the Government in this regard.
