- (a) whether a notification has been issued of Central Government for fixing 5 per cent reservation for the handicapped persons in the vacancies to be filled in Government/Semi Government|Public Undertakings both at the Centre and State level;
- (b) if so, how many vacancies have so far been filled against this quota by absorbing the handicapped persons; and
- (c) if the reply to part (a) be in the negative what are the difficulties being faced by the competent authorities and what steps Government propose to take in. this connection?

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (SHRI KAMAL MORARKA): (a) In respect of appointments by direct recruitment under the Central Government, orders providing for reservation at 3 per cent in identified posts in Groups 'C & 'D' for the physically handicapped, were issued on 4-11-77. Reservation in promotion for the physically handicapped has been introduced w. e. f. 20-11-89 at 3 per cent while making promotions in identified posts within and upto Group 'C\

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (SHRI KAMAL MORARKA): (a) No, Sir.

(b) and (c) The Conduct Rules govern-. ing the service conditions of the officers of All India Services and other Allied Services enable any members of the family of an officer to engage in a trade or business, on the condition that this fact is reported to the Government. In view of this, the Government do not gnd it necessary to conduct inquiries into the details of business and industries being run by the spouses of the officers of All India Services and other Allied Services.

Indo-US Symposium at National Defence Academy, Khadakvasla

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHR LALIT VIJAY SINGH): (a) and (b) An Indo-US Symposium was held at Khadakvasla from the 11th to 13th December, 1990 The Symposium was jointly organised by the Institute for Defence Studies and Analyses, New Delhi, and the Institute for National and Strategic Studies.

National Defence University, Washington. The Symposium was a sequel to an Iado-US Seminar held in Washington in Sept. 89. The Indian and American participants at the Symposium exchanges views and perceptions on various regional and global issues.

Crossing over to Burma by ULFA Chief and others

- (a) whether Government are aware that the Chief of United Liberation Front of Assam alongwith extremists of Nagaland and Manipur have crossed over to Burma; and

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY INFORMATION BROADCASTING (SHRI SUBODH KANT SAHAY): (a) and (b) As per news item originated from Manipur, the Chairman of ULFA had crossed over to Burma alongwith the Chairman, NSCN and Chairman UNLF. But this information could not be corroborated. However Govt. has taken various measures to intercept and apprehend the ULFA extremists while on transit from Assam to Burma and all the neighbouring States have been alerted against any possible crossing over of ULFA extremists.

Per capita income

THE MINISTER OF STATE IN THE MINISTER'S OFFICE (SHRI PRIME KAMAL MORARKA): (a) According to quick estimates of Per Capita Net State Domestic Product at current priced for 1988-89, the States of Andhra Pradesh, Assam Bihar, Himachal Pradesh, Kamataka, Madhya Pradesh Manipur. Nagaland. Orissa. Rajasthan, Tamil Nadu, LTttar Pradesh and West Bengal have Per Capita NSDP bejow the all India Per Capita. Net National Product, (NNP). Estimates in respect of Janum* & Kashmir, Megbalaya, Mizoram, Sikkim and Tripura are not available for 1988-89. However, on the basis of latest figures for 1986-87 for which the estimates are available, out of these States^ Jammu & Kashmir, Meghalaya & Tripura had per capita NSDP below the all India Per capita NNP in 1986-87.

- (b) The per capita all India NNP *rot* 1988-89 is Rs. 3835/-.
- (c) 19 States have made available their income estimates for 1988-89 to CSO, For other states, the latest estimates relate to 1986-87 or 1987-88.
- (d) The steps taken to improve¹ per capita income ace, increased investments/ outlays for the development of infrastructure, agriculture, rural development, irrigation, industries, education, health, employment and better utilisation of invested capital. Moreover, per capita income, is one of the criteria taken into consideration while allocating central assistance to States (other than special category states) for financing their Plans.
