Of these, 99 have been approved and letters of intent granted. Of the remaining 176 applications, 124 have been rejected or otherwise disposed of and 52 are at various stages of processing. It is the constant endeavour of the Government to dispose of all Industrial Licence applications as expeditiously as possible.
