THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SHANTILAL PURUSHOTTAMDAS PATEL): (a) No, Sir. Exports made under counter trade, under the Evidence Account mechanism earn free foreign exchange.

- (b) As per the terms and conditions of the Trade and Payments Agreement concluded by India with each of the Rupee Payment Partner countries, the goods purchased by each country from the partner country are meant strictly for meeting domestic requirements only and cannot be re-exported. Government is, however, aware that there are at times complaints alleging that exports from India are being diverted by the buying organisations. If any specific instance of violation of the agreement comes to the notice of the Government, it will certainly look into the matter.

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE AND THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DIGVIJAY SINGH); (a) The provisional

- collection figures for Direct and Indirect Taxes upto 30-11-90 are Rs. 3,442.79 crores and Rs. 27,327.00 crores respectively.
- (b) The accumulation of arrears and recovery of Taxes are continuing processes and steps are taken from time to time to liquidate the arrears.
- (c) The total revenue collection from direct and indirect taxes upto 30-11-1990 is Rs 30.769.79 crores.

It is not possible to estimate the impact of revenue collection on bringing down the deficit in the Budget estimates at this stage.
