Providing Sea Transport Facilities, to Exporters of Tamil Nadu

- 41. SHRI S. MADHAVAN; Will the Minister of COMMERCE be pleased to state:
- (a) whether the exporters of leather and readymade garments from Tamil Nadu are finding it difficult to export their goods by air to Europe and USA due to rise in air fare:
- (b) whether they have demanded transportation facilities by sea; and
- (c) if so, what are the details of action taken by the Central Government to help these exporters?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SHANTILAL **PURUSHOTTAMDAS** PATEL): (a) to (c) There is mounting demand for air cargo capacity for carriage of export consignments of readymade garments and leather. Special arrangements including operation of additional flights by Air India and adoption of an Open Skies Policy have been made to meet this demand. Freight rates are revised from time to time in relation to costs. The sea mode of transportation supplements the cargo capacity and is resorted fo also in view of lower freight costs ana higher returns that it offers to exporters. Arrangements to meet the anticipated demand for air cargo capacity during the ensuing season and also to streamline carriage by sea and by sea-aid combination are being made in consultation with the concerned export promotion councils.

Mass Casual Leave taken Tjy the Customs Appraisers of Madras
