Defects in EOU Scheme

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SHANTILAL PURUSHOTTAMDAS PATEL). (a) Confederation of 100 per cent Export Units has been making suggestions in regard to the 100 per cent EOU Scheme, from time to time

- (b) The suggestions, among others, relate to customs procedures and problems and also regarding grant of CCS to 100 per cent EOUs, as are applicable to units in the Domestic Tariff Area.
- (c) The problems relating to Customs have been taken up with Department of Revenue at appropriate levels and that Department is examining the suggestions made by the Confederation. Their suggestions for grant of full CCS, instead of 50 per cent of the normal rate, has been agreed to recently, subject to the condition that at least 75 per cent of the raw materials used are of indigenous origin.
