**Help to H.P. Government in boosting tea industry**

**2. SHRI KRISHAN LAL SHARMA** Will the Minister of COMMERCE be pleased to state:

(a) what is the role of the Tea Board in the programme to boost tea industry in Himachal Pradesh;

(b) whether Central Government have given any financial aid to the Himachal Pradesh Government for the purpose; and

(c) if so, the quantum thereof?

**THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SHANTILAL PURUSHOTTAMDAS PATEL):** (a) Several tea development Schemes of the Tea Board such as rejuvenation and replantation subsidy, interest subsidy on bank loan for irrigation, drainage and extension planting, supply of machinery and irrigation equipment under Hire Purchase Scheme and long-term loan under Replantation Finance Scheme, are in operation in Himachal Pradesh. Besides, a new scheme to provide subsidy for supply of irrigation equipment to the small growers had also been sanctioned by the Tea Board.

(b) and (c) So far Tea Board has provided a sum of Rs 38.96 lakhs as loan and Rs. 16.18 lakhs as subsidy.

**Effect of bulk selling of castor oil in Holland**

**3. SHRI B K. HARIPRASAD:** Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that the present practice of selling bulk quantities of castor oil in Holland has led to crash in prices and thereby adversely affecting the interests of India, and

(b) if so, what corrective steps are proposed for the future to protect national interests?

**THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SHANTILAL PURUSHOTTAMDAS PATEL):** (a) and (b) Rotterdam in Holland is a major trading centre for vegetable oils. To minimise freight rates castor oil is shipped in bulk. All exports are not through Rotterdam. Price levels are governed by global supply and demand position. The recent fall in price is due to higher production levels in India and Brazil.

**Net collection by National Savings Organisation**

(a) whether it is a fact that the National Savings Organisation (NSO) has been showing upward trend of net collections during the successive five-year plans since independence,

(b) whether it is also a fact that the National Savings Organisation has achieved the desired objectives,

(c) if the answers to parts (a) & (b) above be in the affirmative, what are the reasons for proposed closure of National Savings Organisation; and

(d) whether Government propose to review the proposed closure of National
