- (g) Large number of villages marooned.
- Extensive damage to public properties Roads* Bridges-private houses and standing crops besides severe damage to Minor Irrigation projects.
- (i) Human and Animal casualties reported.
- (i) Loss as per preliminary report is estimated over several crores.
- (k) Extensive damage caused in Puri and Cuttack districts.
- (b) A Central Reconnaissance team visited the State on 13—16 November, 1990 to have first hand information on the situation caused by this calamity. The team was not required to assess the extent of damage caused by the Calamity. The team identified a number of points with regard to immediate relief and rehabilitation of the affected people in the area. The concerned Departments of Central Government have taken necessary action on these ponits. The details of the assistance provided by Central Government to Government of Orissa for relief and rehabilitation of the effected people are given in the statement.

Assistance provided by Government of India to the State Government of Orissa in the wake of heavy rains and floods in November, 1990

- —All the four quarterly instalments of Centre's share towards State Calamity Relief Fund for 1990-91 amounting to Rs. 35.25 crore has been released.
- -An amount of Rs. 2.50 lakh has been released for pest control. In addition, Rs. 560.04 lakh has been sanctioned to the State Government under Integrated Rice Development Programme'.
- —General Insurance Corporation has been instructed to settle the in-sum nee claims on priority basis.

-Necessary quantity of seeds as available National Seeds Corporation (NSO/State Farming Corporation of India (SFCI) have been supplied to the State

to Questions

- -Steel Authority of India and Tata Iron and Steel Company have since been instructed to meet the requirement of materials of the Orissa State Electricity Board immediately.
- -National Bank for Agricultural and Rural Development (NA-BARD) and Reserve Bank of India (RBI) have issued necessary instructions to the Banks in Orisa for rescheduling old loans and providing necessary fresh loan assistance to the affected people,
- -Chief, Housing and Urban Development Corporation (HUDCO) located Bhubaneshwar is maintaining constant contact with the State Government for finalisation of Housing Project at an early date.
- -Director General, Health Services is maintaining constant contacts with the health authorities of the State Government for malaria eradication programme and providing medicines, vaccines and dis-infectants.
- —A task force from the Department or Telecommunication has already visited the affected areas between 2nd and 5th December, 1990. 90% of the restoration work has been completed.

THE MINISTER OP RAILWAYS (SHRI JANESHWAR MISHRA): (a) No, Sir.

(b) The Railways on account of ope. rational necessities, and for increasing efficiency and bringing about economy, have decided to replace steam locomotives by the year 2000 A number of steam staff has been retained at the same place of work as they were engaged in other activities which would continue to remain at the station. The maintenance staff rendered surplus are being redeployed at the same or nearby locations after re-training. Railway as a policy do not retrench any staff. The steps have been taken in consultation with the recognised unions. Any useful material, machinery and plant etc. which is no longer required at their present location would be shifted to alternative areas in the national interest.

Short supplies of consumer goods at Fair **Price Shops**

- 150. SHRi ANANT DAVE: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:
- (a) whether Government are aware that the Wheat, Rice, Sugar and Pal-molein Cooking Oils are in short supply and are mostly not available at Fair Price Shops in the various parts of the country; and
- (b) what steps Government are taking to make these items available freely at the Fair Price Shops?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL (SHRI SARWAR HUSSAIN): SUPPLIES (a) and (b) No reports of such shortages of rice, wheat and sugar have been received from State Govts./ UT Administrations. There are adequate stocks of rice, wheat and sugar in the Central Pool. There is, however, shortage of palmolein, currently, due to lack of import. Government is however, considering measures to remedy the situation. PDS allocations, nevertheless, are supplemental in nature and are not intended to meet the entire requiremnt of States/ UTs.
