Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) the consumer retail market prices of essential commodities, as on November 1 of 1988, 1989 and 1990 alongwith their prices, on the first of each month of 1990.
- (b) the administered prices of the each commodities; and
- (c) whether prices have also increased due to an increase in the cost of transportation which increased due to the raise in the administered prices of diesel and petrol and also a raise in the railway freights, if so, to what extent?

- (b) A Statement showing the Central Issue Prices of Rice, Wheat and Sugar, ex-storage prices of Petroleum Products and Iron & Steel is given at Annexure-III (See Appendix CLVI, Annexure No. 9).
- (c) In the Railway Budget for 1990-91, the railway freight rates were increased by 7 per cent w e f. 1-4-90 and by 10 per cent w e f. 1-10-1990. However, foodgrams, pulses; edible salt, edible oils, fruits and vegetables, sugar, gur and Jagree were exempted from both the increases Hence, there was no increase in the railway freight for the aforesaid commdities.

While, it is not possible to quantify in precise terms the impact of increase

in transport cost due to hike in prices of diesel and petroleum products, it has contributed to the inflationary pressures.
