THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRi RAO BIRENDRA SINGH): (a) A statement showing the monthwise percentage variation in the Wholesale Price Index (WPI) of Pulses, Edible Oils, and other important sale-groups of essential commodities such as cereals, vegetables, sugar, *khandsari* and *Gur* from November, 1989 to November, 1990 is given in Annexure [See Appendix CLVI, Annexure No. 4].

(b) The Government has accorded highest priority to check the rising trend in prices of essential commodities. Both long term and short term measures are, therefore, being taken for the purpose. The measures taken broadly include steps to increase pro-duct'on of essential commodities, procurement and buffer stocking operations of foodgrains. strengthening Of Public Distribution System, enforcement of the provisions of the Essential Commodities Act and other regulatory measures, and augmenting domestic supplies through imports wherever necessary so as to check any abnormal rise in the prices of essential commodities.

The various measures taken by the Government have resulted in checking runaway increase in prices of most of the essential commodities and softening in prices of items like rice, gram. *arhar*, potatoes, sugar; *gur vanaspati* and tea etc. in recent weeks.
