THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) to (c) The works relating to planning, designing and construction of hotels and renovation thereof are specialised and complicated in nature. Accordingly, the specialists like Architects, Interior Designers and Interior Decorators etc. are empanelled through open advertisement and with the approval of the Board of Directors. The works are awarded to the empanelled parties by inviting tenders from these enlisted parties. Depending upon the location, magnitude and nature of works, both systems of tendering are being followed namely, open tenders through wide press publicity, and limited tenders, through approved panels.

A comprehensive list giving names and addresses firms/comofparties, panies/suppliers/individuals alongwith the amount and type of work/supply awarded for each unit/division of ITDC is enclosed in Annexure. [see Appendix CL.VI, Annexure No. 6]

Development of various tourist spots in tourism year 1991

- 215. SHRI S. S. AHLUWALIA: Will the Minister of TOURISM be pleased to state:
- (a) whether it is a fact that the year 1991 would be observed as Tourism Year;
 - (b) if go, what are the details thereof;

- (c) whether Government have cho sen to project the tourist and religious places in Bihar such as Bodhgaya, Jain Temples, Patna Sahib, Nalanda, Raj gir etc. to attract the tourists on. flow in 3 the State;
 - (a) if so, whether Government have any plan to decorate, illuminate these places and distribute pamphlets on them at national and international level to attract the internal and foreign tourisis; and
 - (b) if so, the details thereof and the special tr&nsport arrangements for tourists made by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) and (b) Yes, Sir. Besides traditional tourist circuits, new extension circuits have been identified for promotion. 46 fairs and festivals are being promoted all over the country.

- (c) Yes, Sir.
- (d) and (e) General brochures for distribution amongst the domestic foreign tourists have been brought out including a map of the region. Pre sently, there are no plans to decorate and illuminate these places. As re gards special transport arrangements for tourist, it is the responsibility of the State Government.

Steps taken to develop and boost rural tourism in the country

- 216. SHRI SURESH KALMADI: Will the Minister of TOURISM be pleased to state:
- (d) whether Government have taken steps to develop and boost rural tourism in India; and
 - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) and (b) In order to develop and boost rural tourism in the country, the Mi- nistry of Tourism extends financial assistance to State Governments for organising rural craft melas and rural

fairs and festivals. In addition the Government have a scheme under which incentives are giveli to enter-preneurs for setting up of hotels in rural areas of the country.

Decline in the number of foreign tourists visiting Maharashtra

- 217. SHRI SURESH KALMADI: Will the Minister of TOURISM be pleased to state:
- (a) whether it i_s a fact that the Tourism inflows from other countries to India and particularly in the State of Maharashtra has dampened;
- (b) i'f so, the reasons therefor and the steps proposed to be taken by Government to boost the tourism; and
- (c) the number of foreign tourists having visited Maharashtra during the year 1989 and 1990?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) Yes, Sir.

- (a) The disturbances in some parts of the country and the adverse reporting of these events in the overseas markets, international developments like, Gulf crisis, restructuring of economy in Soviet Russia, etc. are the main reasons for the decline in tourist traffic. The steps taken by the Government for boosting tourism include diversification of tourism resources, development of new circuits, relaxation of rules relating to issue of visa and restricted area permits, etc., provision of money changing facilities in approved hotels, etc.
- (b) Comparable figures of tourist arrivals in Maharashtra during 1990 are not available from the State Government. However, as per the disembarkation statistics available 488,681 foreign tourists disembarked at Bombay Airport till November 1990 as compared to 496,719 disembarkations during the same period in the previous year.

Creation of Heritage Hotels

218. SHRI SURESH KALMADI: Will the Minister of TOURISM be pleased to state:

(a) whether it is a fact that Gov-

ernment have decided to create new type of Hotels - to be called 'Heritage Hotels' by converting Historical Buildings and Havelies into Hotels- and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) and Ob) Government propose to include Heritage Hotels as a classification standard along with one to five star categories. The category is being introduced to cover running hotels that have been built in traditional Residences. This is being intorduced in Rajasthan at the first instance in consultation with State Government and hotel owners, as a voluntary scheme

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JAYANTILAL VIRCHAND-BHAI SHAH); (a) and (b) States/ U.Ts. wise details of damage to life and properties due to floods, heavy rains and land slides, as reported by them, during the years 1987-88, 1988-89 and 1989-90 are given at Annexure I. IT and III respectively. [See Apendix CLVI. Annexure No 7]
