- (ग) और (घ) जी, हां। देश के विभिन्न राज्यों में धान की उत्पादकता में काफी अन्तर है। 1989-90 के दौरान बड़े उत्पादक राज्यों में पंजाब की उत्पादकता सबसे ग्रधिक (5239 कि ब्या ० / हैक्टेयर) थी जबकि सध्य प्रदेश की उत्पादकता सबसे कम (1392 कि ज्या व हैक्टेयर) थी।
- (इ.) जी, हां। वैज्ञानिकों ने धान की अनेक अधिक उपज देने वाली किस्में विकसित की हैं, तथा उत्पादन की ग्रधिक-तम बनाने के लिए राज्यों में इनका

अधिकाधिक उपयोग किया जा रहा है। 1989-90 में इन किस्मों वाला क्षेत्र लगभग 65.5 प्रतिशत था।

- 147. SHRI SANTOSH KUMAR SAHU Will the Minister of AGRICULTURE be pleased to state:
- (a) when the State Government of Orissa had sent the preliminary report on the floods in the Ganjam district of Orissa to the. Central Government, and what are the details of the loss of human lives, cattle, houses and public properties; and
- (b) whether any Central team had visited the area and assessed the loss and if so, what assistance has been—given by the Central Government to rehabilitate the flood victims?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICUL TURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JAYANTILAL VIRCHANDBHAI SHAH): (a) The preliminary repoit on the floods in the Ganjam District of Orissa was received by Government of India on 7th November, 1990. Details of damage as reported by the State Government due to this calamity in this report are as under:-

- (a) Hundreds of villages submerged in Ganjam District.
- (b) Large number of roads and high level bridges washed away causing serious disruption of Road Communication.
- (c) Two Buses washed away on Didpahandi-Taptapani State high way. All passengers excepting one lady rescued.
- (d) 3 Towers of 220 K.V. line of Bhanjangar Theruvalli line washed away.
- (e) flood water overtopped Railway
- (f) 11 Blocks of Ganjam district severely affected.

- (g) Large number of villages marooned.
- Extensive damage to public properties Roads* Bridges-private houses and standing crops besides severe damage to Minor Irrigation projects.
- (i) Human and Animal casualties reported.
- (i) Loss as per preliminary report is estimated over several crores.
- (k) Extensive damage caused in Puri and Cuttack districts.
- (b) A Central Reconnaissance team visited the State on 13—16 November, 1990 to have first hand information on the situation caused by this calamity. The team was not required to assess the extent of damage caused by the Calamity. The team identified a number of points with regard to immediate relief and rehabilitation of the affected people in the area. The concerned Departments of Central Government have taken necessary action on these ponits. The details of the assistance provided by Central Government to Government of Orissa for relief and rehabilitation of the effected people are given in the statement.

Statement

Assistance provided by Government of India to the State Government of Orissa in the wake of heavy rains and floods in November, 1990

- —All the four quarterly instalments of Centre's share towards State Calamity Relief Fund for 1990-91 amounting to Rs. 35.25 crore has been released.
- -An amount of Rs. 2.50 lakh has been released for pest control. In addition, Rs. 560.04 lakh has been sanctioned to the State Government under Integrated Rice Development Programme'.
- —General Insurance Corporation has been instructed to settle the in-sum nee claims on priority basis.

-Necessary quantity of seeds as available National Seeds Corporation (NSO/State Farming Corporation of India (SFCI) have been supplied to the State

- -Steel Authority of India and Tata Iron and Steel Company have since been instructed to meet the requirement of materials of the Orissa State Electricity Board immediately.
- -National Bank for Agricultural and Rural Development (NA-BARD) and Reserve Bank of India (RBI) have issued necessary instructions to the Banks in Orisa for rescheduling old loans and providing necessary fresh loan assistance to the affected people,
- -Chief, Housing and Urban Development Corporation (HUDCO) located Bhubaneshwar is maintaining constant contact with the State Government for finalisation of Housing Project at an early date.
- -Director General, Health Services is maintaining constant contacts with the health authorities of the State Government for malaria eradication programme and providing medicines, vaccines and dis-infectants.
- —A task force from the Department or Telecommunication has already visited the affected areas between 2nd and 5th December, 1990. 90% of the restoration work has been completed.
