MINISTRY OF AGRICULTURE VIRCHAND-(SHRI JAYANTILAL BHAI SHAH), (a) and (b) Considering the dangers of health hazards and poisoning due to improper usage of pesticides and other accidental incidence, the Government are emphsasing on safe and judicious use of chemical pesticides The Government are also encouraging the adoption of biological control for pest control in agriculture Similarly, the Government is also supporting the use of biol-fertilizers and organic manures for supplementing the use of chemical fertilizers

The Government are proposing to undertake an expanded programme of Integrated Pest Management including biological control during the VIIIth Five Year Plan and is placing high emphasis on this programme

- (c) Based on the research investigations conducted, some of the important publications like
  - (1) Problems and prospects of Botanical Pesticides in Integrated Pest Management; and
  - (ii) Biological control on identified crop pests have been published
- (d) At present, biol\_control agents are being introduced and distributed by 11 Central Biological Control Stations set up by the Government of India in different parts of the country. Some smaller units have also been set up by a few State Governments One private company is also selling these agents on commercial scale However, the Government are proposing to expend these facilies in the Government sector and are also encouraging public and private sector companies to undertake their production and sale

MINISTER OF STATE IN THE THE DEPARTMENT OF AGRICUL-TURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI JAYANTILAL VIRCHAND-(a) and (b) Certain BHAI SHAH) restrictions were imposed on supply of High Speed Diesel (HSD) through retail outlets throughout the country An 8 per cent cut was applied on supplies of HSD to Retail Outlets w.ef 8th October, 1990 which was increased to 10 per cent from 1st November 1990 Since the restrictions on release of HSD to retail outlets coin. cided with the Ki rif Harvesting sea son and rabi sowing season, there has been marginal adverse effect on farm operations in some of the Instructions were issued to Governments and Oil Companies to give priority to agricultural operations in distribution of diesel at the retail level In fact priority given for diesel to farmers in most States The 10 per cent cut on supplies of HSD to retail outlets withdrawn wef November 26 1990 which has provided substantial lief to the transport and agricultural sectors throughout the country

- (b) No, Sir, All complaints, whether verbal or in writing, as and when received are promptly attended to Complaint boxes have been provided at the main branches at Connaught Place INA and Patel Nagar, and complaint registers are available at the smaller outlets Senior officers have also fixed time for visitors/consumers to attend to their grievances promptly.
- (c) The working of Super Bazar is reviewed by the managing committee

as well as Deptt of Civil Supplies. Govt of India from time to time to make it more effective and efficient. The Department exercise control over the working of the store through official members nominated on the managing committees of the Store.

(d) Complaints are dealt with by the senior officers and Vigilance Wing of the Super Bazar and the erring employees are punished suitably During the year 1990, three employees have been punished on the basis of the complaints received from the public In two cases, warning has been issued and in one case, penalty of censure has been imposed-

(a) to (d) Construction of underground roads (Subways) in Connaught Place area in the function of the New Delh<sub>1</sub> Muncipal Committee The NDMC has reported that the subway at the inter-section of Sansad Marg with outer circle has already been commissioned. Work on two more subways, namely at the intersections of Janpath and Baba Kharak outer circle Con-Singh Marg with naught Place is in progress and is scheduled for completion in March 1991 and March 1992 respectively. NDMC has plans for constructing a few more subways in the Connaught Place area such as Panchkum Road, Barakhamba
