fairs and festivals. In addition the Government have a scheme under which incentives are giveli to enter-preneurs for setting up of hotels in rural areas of the country.

Decline in the number of foreign tourists visiting Maharashtra

- 217. SHRI SURESH KALMADI: Will the Minister of TOURISM be pleased to state:
- (a) whether it i_s a fact that the Tourism inflows from other countries to India and particularly in the State of Maharashtra has dampened;
- (b) i'f so, the reasons therefor and the steps proposed to be taken by Government to boost the tourism; and
- (c) the number of foreign tourists having visited Maharashtra during the year 1989 and 1990?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) Yes, Sir.

- (a) The disturbances in some parts of the country and the adverse reporting of these events in the overseas markets, international developments like, Gulf crisis, restructuring of economy in Soviet Russia, etc. are the main reasons for the decline in tourist traffic. The steps taken by the Government for boosting tourism include diversification of tourism resources, development of new circuits, relaxation of rules relating to issue of visa and restricted area permits, etc., provision of money changing facilities in approved hotels, etc.
- (b) Comparable figures of tourist arrivals in Maharashtra during 1990 are not available from the State Government. However, as per the disembarkation statistics available 488,681 foreign tourists disembarked at Bombay Airport till November 1990 as compared to 496,719 disembarkations during the same period in the previous year.

Creation of Heritage Hotels

ernment have decided to create new type of Hotels - to be called 'Heritage Hotels' by converting Historical Buildings and Havelies into Hotels- and

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRIMATI USHA SINGH); (a) and Ob) Government propose to include Heritage Hotels as a classification standard along with one to five star categories. The category is being introduced to cover running hotels that have been built in traditional Residences. This is being intorduced in Rajasthan at the first instance in consultation with State Government and hotel owners, as a voluntary scheme

(c) Statement indicating the amount of Central assistance sought by the affected States/U.Ts for meeting ex penditure on relief operations 'in the areas affected by these calamities is given at Annexure IV.

- (d) & (e) Government of India have been taking number of measures for meeting the situation arising out of these calamities effectively. These me asures are:
 - 1 . Improving flood forecasting and warning system.
 - 2. Modifying the susceptibility flooding channel through improve ment diversion of flood water. watershed management, flood plain zoning etc.
 - 3, Developing alternative crop ping strategies.
 - (b) Spreading the loss through credit support and insurance scheme.
 - (c) Modifying the floods through reservoirs, detention basins, embankments, coastal embankments, construction of sea wails etc.
 - (d) Preparation and implementation of Master Plan for flood control and management in each flood-prone basin.
 - (e) Afforestation programmes in the catchment areas etc.
