  - (c) and (d) The management of Super Bazar tried to solve the grievances of employees by offering certain benefits subject to the signing of long term memorandum of settlement and maintenance of industrial peace in September, 1990 but the employees union did not fulfill its part of obligation and went on strike from 23-11-90

The management of Super Bazar has appointed a sub-committee comprising of four members of the Managing Committee to look into the demands of the employees within the overall financial capability of the Super Bazar
