[Shri A. G. Kulkami] the proxies by LIC officers. When the LIC officials wanted, the proxies were not made available for being shown to the LIC officials. Now, Mr. Jajoo who went to the High Court was asked to examine, it was found out that only 8000 proxies were there and out of that 22 per cent of proxies had forged signatures and in case of 6 per cent of the proxies, the persons who were supposed to have signed had expired and gone above but their proxies were also there. This is a very serious matter. What is happening in this country? The role of these industrial houses which are over-riding, steamrolling all morals and values of the corporate world-they call corporate democracy— there should be corporate honesty first. Democracy will come later. I reqquest the Minister of State for Finance...

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR): Mr. Kulkarni, on an important issue, one sentence is enough

SHRI P. UPENDRA (Andhra Pradesh): Sir, the General Body Meeting is going to be held on Monday. The Minister here should take note of it.

SHRI A. G. KULKARNI: Before 16th, the role of LIC in re-examining the proxies must be insisted on and each and every proxy must be examined since Mr. Jajoo has found that about 30 per cent of the proxies out of 8000 were pure fabricated forgery.

Recruitment in Jammu and Kashmir Police Force on the dictates of militants

SHRI JAGMOHAN (Nominated): I wish to bring to the notice of the House the reports that are appearing in the press that militants are virtually recruiting people on behalf of the Government in the police of Kashmir. I would request the hon. Home

Minister to look into this. There are reliable reports that about 12,000 vacancies are being filled on ad hoc basis and that is being done on the dictates of the militants. They just supply the list and blank departmental orders are being given by the officials and only names are filled up by the militants. Already we have suffered quite a lot due to internal subversion and if this further goes deep into the administration, problems will be far more complicated than they are at present. This has to be looked into immediately. That is my submission. Thank you.
