

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) and (b) Most of the large units producing petroleum, iron, pulp and paper have already set up effluent treatment plants.

(c) Government has given time till December 31, 1991 to meet the prescribed standards for the industries that belong to the 17 highly polluting categories. The States have been directed to enforce this time limit. In addition fiscal incentives are provided for insallation of pollution control equipment and shifting of polluting industries from congested areas.
