#### **Loan waiver scheme covering non-nationalised banks**

299. SHRI BHUVNESH CHATURVEDI: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that loan waiver scheme covers only the loans given by nationalised banks and not non nationalised banks;

(b) if so, the reasons therefor;

(c) whether it is a fact that Reserve Bank of India has recommended to Government to cover loans given by non-nationalised banks under the Scheme: and

(d) if so, what is Government's reaction thereto ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI DALBIR SINGH): (a) and (b) As per the provisions of the Agricultural and Rural Debt Relief (ARDR) Scheme, 1990, the loans issued only by Public Sector Banks, Regional Rural Banks and Cooperative Banks are eligible for relief under the Scheme. The Scheme was limited to the above category of banks only, and no other types of credit institutions were brought under its purview.

(c) Yes, Sir.

(d) The Government do not propose to make any changes in the Scheme, and private sector banks will not be covered under the Scheme.

#### **Research fellowships allotted to Delhi University**

302. SHRI KAMAL MORARKA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) what is the number of research fellowships allotted to the Delhi University by University Grants Commission and other agencies; and

(b) what is the availability of research fellowships in different Departments of Delhi University ?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) According to the information furnished by University of Delhi, UGC has allotted 119 Junior Research Fellowships (JRFs) to the University for award to candidates who have qualified in National Education Test (NET) examination for doing M. Phil./ Ph. D. According to information furnished by UGC, the Commission has also allotted 228 positions of JRFs on supernumerary basis to the University. These candidates register themselves for M. Phil/Ph. D. in the Department of their choice. University of Delhi has also been given 53 Junior
