486. PROF. SOURENDRA BHATTACHARJEE: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether Government has received full report of the present situation of the Government of USSR by now;

(b) if so, the details thereof;

(c) whether relationship between the countries were affected due to certain changes; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI EDUARDO FALEIRO): (a) and (b) Political developments in the USSR are taking place at a rapid pace. Government are closely monitoring the changes. Regular & detailed reports are being received in this connection from our Embassy in Moscow. There is also extensive media coverage of these changes.
