Tendu leaf plucking- worker

795. SHRI SURESH PACHOURI: Will the Minister of LABOUR be pleased to state:

- (a) whether Government propose to oring the Tendu leaf plucking workers, mostly Adivasis, under the purview of the Beedi and Cigar Workers (Conditions of Employment) Act, 1966;
- (b) if so, by when the proposal it. likely to be implemented; and
- (c) if answer to part (a) above be in the negative the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI PABAN SING GHATOWAR): (a) Sir.

- (b) Does not arise.
- (c) The working conditions and problems of Tendu leaf pluckers are quite different from those of beedi workers. It is, therefore not possible to bring Tendu leaf pluckers under purview of Bidi & Cigar Workers (Conditions of Employment) Act. 1966.

Demands for Railway station at Malanpur

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) and (b) Government of Madhya Pradesh had requested last year for realignment of Guna-Etawah new line via Malanpur. A revised feasibility survey has been

taken up. Final decision will be taken based on the result of the sur vey.

Confirmation in C.P.W.D

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVE-LOPMENT (SHRI M. ARUNACHA-LAM): (a) to (c) CPWD is maintaining the Communal Roster for filling up of reserved vacancies/posts for SC/ST in the grade of Asstt. Engineers on Promotion through Selection/ Limited Departmental Examination and recruitment to the posts of JEs'. Communal Roster was also being maintained upto 31-3-88 for confimation also. From 1-4-88 Roster is not required to be maintained confirmation as per the fresh Govt, policy, delinking confirmation from availability of permanent posts.
