THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI PABAN SINGH GHATOWAR): (a) The number of bonded labour identi-

fied in Orissa, Madhya Pradesh and Bihar as on 31-3-89, 31.3.90 and 31-3-91 are given as under:—

(b) A Centrally Sponsored Scheme was launched by Ministry of Labour in 1978-79 under which the Central Governments are provided on matching assistance grant (50:50) basis for the rehabilitation of bonded labourers. The Scheme envisages provision of rehabilitation grant upto a ceiling limit of Rs. 4000 per bonded labourers (raised to Rs. 6,250 - w.e.f. 1.2.1986) half of which is given as Central share. So far, a sum of Rs. 3514.06 lakhs has been released to them as Centra! share of assistance.

Mineral Rich Blocks in Maharashtra

783. SHRI VISHWASRAO RAM-RAO PATIL: Will the Minister of MINES be pleased to state:

- (a) the locations of the Mineral rich blocks in the Maharashtra as per the Geological survey done in that State; and
- (b) the steps taken by Government for their proper exploitation?

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) The Geological Survey of India the Directorate of Geology & Mining, Govt of Maharashtra and other Central State Agencies have conducted surveys for finding mineral deposits in Maharashtra. Locations of the blocks having occurrences deposits of important minerals are given below mineral-wise:—

Copper-Ore : Thanewasna and Dubarpeth in Chandrapur district, Pular-Parsori in Nagpur district.

Zinc-Ore: Tambekhani, Kolari, Bhaonri in Nagpur district.

Tungsten-Ore: Agargaon, Kuhi, Khobna and Bhaonri in Nagpur district.

Manganese-Ore : Chikla and Dongri Buzurg in Bhandara district, Dumri Satak and Parseoni in Nagpur district and Hiwri in Yavatmal district

Bauxite: In different parts of the districts of Satara, Ratnagiri, Thane, Kohlapur and Raigarh.

Barytes: Phutana and Mahadwari in Chandrapur district.

Limestone : Naokari-Kusumbi belt, Yavatmal district.

Kyanite-Sillimanite' Dahegaon-Pimpalgaon, Bhandara district.

Iron Ore: Wurrea Hill, Puser and Lohara in €handrapur and Gadchiroli districts and Redi area in Ratnagiri district.

Coal : Chanda-Wardha, Kamptee, Umrer, Bander, Nand ,Makardhokra and Bokhara

(b) The exploitation of minerals is carried out based on the techno-economic feasibility of the deposits. Principal minerals under exploitation were Coal, Bauxite, Iron Ore, Manganese Ore, Kyanite, Sillimanite and Limestone.
