THE MINISTER OF STATE IN THE CHEMICALS MINISTRY OF FERTILIZERS (SHRI CHINTA MOHAN): (a) The fertilizer factory at Gorakhpur was closed on account of an accident which took place on 10th June, 1991, due to bursting of a Thereafter, Fertilizer pipeline. Corporation of India was directed by Directorate of Factories, TIP., to get health survey done by a third party before re-starting the plant. A detailed health survey is being conducted which is likely to be completed by October 1991,

(b) After getting recommendation of the Board of Directors of Fertilizer Corporation of India on health survey report of the unit, the Government will take a decision on the future running of the plant.
