Indigenous drag for cancer core

(a) whether Government's attention has been drawn to news item appeared in Indian Express, Hyderabad on 10th August, 1991, captioned "Indigenous Drug for cancer cure";

(b) whether it is a fact that Technology for latest cancer drug has been developed by Indian company with

the collaboration of the Government Laboratory;

(c) if so, what are the details thereof;

(d) whether it is also a fact that the drug is considered to be a major advancement of cancer chemotherapy;

(e) whether it is a fact that this drug is allowed for import;

(f) if so, what was the quantity imported during the last three years and what is the estimated demand;

(g) what is the price fixed for imported injection and at what price each injection is being sold; and

(h) whether it is a fact that indigenous injection is being offered at half the price?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN):

(a) to (d) M/s. Cipla has in the past introduced some anti-cancer drugs in collaboration with National Laboratories. However details have not been received in this Department about the latest anti-cancer drug introduced by them.

(e) Yes. Sir.

(f) Details of import of formulations are not being monitored by this Department. Demand estimation for this drug has also not been done.

(g) and (h) None of the anti-cancer bulk drugs are price controlled under DPCO. However importers of anticancer formulations are required to charge not more than 50 per cent of the landed cost to meet distribution costs, transport costs and other charges inclusive of margins.
