#### **Promotion of Urdu by Bureau for promotion of Urdu**

\*34. MAULANA OBAIDULLAH KHAN AZMI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state;

(a) whether it is a fact that Bureau for promotion of Urdu has failed to act as an effective body and to achieve its goal of promotion of Urdu;

(b) whether Jafri Committee on Urdu has also expressed its dissatisfaction on the functioning and efficacy of the Bureau; and

(c) if so, what action Government propose to take in the matter?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) In the Report of the Jafri Committee to examine implementation of Recommendations of Gujral Committee for promotion of Urdu, laid on the Table of Rajya Sabha on 25.7.91, the Committee inter-alia, had reviewed the functioning of Bureau for promotion of Urdu. The Committee felt that, as a Subordinate office of the Department of Education, the Bureau has not been able to discharge its functions effectively. The Committee has accordingly suggested that the status of the Bureau should be changed to an autonomous body in order to arm it with functional freedom and enhanced financial powers.

#### **Super Thermal Power project at Mangalore Pending Environmental Clearance**

Revised proposal was again submitted in August, 1990 with inadequate data. Complete details on rehabilitation, fly ash management and implications of the proposed Mulki dam are awaited from the project authorities.
