THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI RANGARAJAN KUMARAMANGLAM): The information is being collected and will be laid on the Table of the House

Strike call to Bank Employees

- 61. SHRI GURUDAS DAS GUP-TA: Will the Minister of FINANCE be pleased to state:
- (a) whether there is a call to strike by employees of the banks in the country; and
- (b) if so, what are their demands and what is the reaction of Government thereto?

THE MINISTER OF STATE MINISTRY OF FINANCE (SHRI DALBIR SINGH): (a) (b) Indian Banks' Association reported that it has received notice for a joint call given by five unions/ associations of the bank employees/ officers for strike on 6-9-1991 against "Move for banks' privatisation". There is no proposal at present under consideration of the Government to denationalise/privatise any public sector bank.

Modification in Procedure for Finalisation of Accounts in Banks

- 62 SHRI GURUDAS DAS GUP-TA: Will the Minister of FINANCE be pleased to state:
- (a) whether Government have decided to introduce changes in the procedure for the finalisation of the final accounts of the banks; and
- (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI DALBIR SINGH): (a) Yes, Sir. A notification in this regard has been issued by Government on 18th January, 1991 giving notice of its intention to modify the formats of Balance Sheet and Profit & Loss Account of commercial banks after expiry of three months from the date of publication of the notification.

- (b) The proposed formats would have inter-alia the following features:—
 - (i) They will give a true picture of both income and expenditure;
 - (ii) They will ensure unformity in the classification of various items of assets and liabalities as well as income and expenditure; and
 - (iii) They will include statements on acounting policies to facilitate easy understanding.
