(b) The project seeks to develop the district level and sub-district level Hospitals, 10 cyclone based medical hospitals, 1 cyclone disaster relief training centre and a T.E. Hospital in Andhra Pradesh. The project cost is Rs. 236.70 crores and it is phased over two plan period VIII and IX Five Year Plan. The proposal has been posed to the World Bank for assistance.

# SHRI ASHOK NATH VERMA:

Will the Minister of ENVIRON-MENT AND FORESTS be pleased to state:

(a) whether it is a fact that the Tehri Hydel Development Corporation has not complied with certain conditions laid down while environmental clearance was given to the project last July, if so, what is Government's reaction in this regard; and

(b) whether Government propose to order stoppage of work on the Tehri Dam under the Environment Conservation Act?

THE MINISTER OF STATE FOR (INDEPENDENT CHARGE) OF THE MINISTRY OF ENVIRON-MENT AND TORESTS (SHR) KAMAL NATH): (a) Yes, Sir. The conditions stipulated while according environmental clearance in July, 1990 have not been complied with by the Tehri Hydel Development Corporation.

(b) A decision to enforce stipulated conditions under the provisions of the Environment (Protection) Act, 1986 is yet to be taken.

## Vocational courses in Governmen Schools in Delhi

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The details of vocational courses being offered at  $\pm 2$ stage in Government/Aided senior secondary schools in Delhi is attached at Annexure and [See Appendix 160, Annexure No. 1]

(b) and (c) The National Council of Educational Research and Training which provides academic support to the programme of vocationalisation has developed and sent to the State Governments 77 competency based curricula for vocational courses. It is however for the State Governments to adopt/adapt the curricula in accordance with their local requirements. According to the available information 150 different vocational courses have so far been introduced in States/ UTs.
