So, what is the necessity for going to the Tribunals? As soon as they produce the legal heir certificates from the competent authority, can't the Tribunal or the person concerned pay the amount immediately in order to avoid the ordeal 12.00 Noon of the people going to the Tribunals? Sir, going to the Tribunal causes a great hardship to the persons injured in the accidents because it is known that he is injured. So where is the question of proving the accident and other things? The fatal accident has oc-cured, the identity of the person who died is known then, where is the question of again going to the Tribunal and giving the evidence. This procedure should be simplified. Those who die in the accident, if their relatives get a legal death certificate and produce it before the Station Superintendent or anybody. . .

A sugar undertaking which has been operational for a minimum of seven crushing seasons including trial crushing season is eligible to avail Sugar Development Fund (SDF) loans for modernisation/rehabilitation. Each application for loan from SDF is considered on merit as per the provisions contained in the Sugar Development Fund Act, Rules and the general guide! nes, No loan is given from SDF for setting up a new sugar factory.

*86. SHRI CHHOTUBHAI PATEL: Will the Minister of FOOD be pleased to state:

- (a) whether Government have received any proposal from the Government of Gujarat for change of the location for establishment of a new Sugar factory in the State; and
- (b) by when the proposal is likely to be finalised?

THE MINISTER OF STATE (INDE-PENDENT CHARGE) OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI): (a) Ministry of Food has received five proposals for change of location in the State of Gujarat out of which four have been recommended by the Government of Gujarat, the details of the proposals are given in the Statement.

(b) Licensing Policy guidelines are presently being reviewed by the Government. As such, the above proposals for change of location would be considered after the aforesaid review.
