- (c) what is the estimated cost benefit ratio of additional investments in base workshop to increase the capacity to carry out periodic overhaul of coaches; and
- (d) what is the schedule of investments on base workshop facilities in the next three years; what is the targeted reduction in percentage of ineffective coaches during the next three years?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MAL-LIKARJUN): (a) The information is as under:

There is thus slight improvement in the ineffective percentage of coaches.

- (b) As a result of reduction of 1 per cent in ineffective coaches, the gain in passengers journeys and revenue is 40.44 million and Rs. 30 crores, respectively.
- (c) The projects are cleared if the Rateof-Return on the investment is estimated at over 12 per cent.
- (d) The investment depends on the availability of funds. Corporate Plan (1985-2000) envisages target for ineffective percentage of coaches as 10 per cent. For 8th Plan period, the target is 9 per cent.

Drought relief to the affected States

182. SHRI RAMSINH RATHWA: SHRI SHABBIR AHMED SALARIA:

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it it a fact that the States of Uttar Pradesh, Haryana, Gujarat. Madhya Pradesh etc. have been hit severally by drought owing to a poor monsoon;
- (b) if so, what are the details of the districts affected by drought in each State throughout the country;
- (c) what are the details of drought reliegiven by Government to each State; and
- (d) what steps Government propose to take to enable the cultivators of drought hit areas to sow their Rabi crops?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI MULLAPPALLY RAMACHANDRAN):
(a) and (b) Parts of Uttar Pradesh, Haryana, Gujarat and Madhya Pradesh had, upto the middle of July, 1991, received deficient rainfall during the current monsoon. This had affected agricultural operations. However, rains in the second fortnight of July and August, 1991 have improved kharif crop conditions.

According to the State Government there are no drought conditions in any pert of Madhya Pradesh.
