Construction of Indian Embassy Building in Brazil

530. SHRI KHAGEN DAS: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether Government are aware that the Government of Brazil had gifted a land in 1965 to the Indian Embassy in Brasilia for construction of an Embassy Complex;

(b) whether the Embassy Complex had been constructed on the gifted land;

(c) if not, what are the reasons therefor; and

(d) how much amount was paid as rent of leased Buildings, expenditure on Property taxes, local taxes, etc. as on the 31st March, 2000?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI JASWANT SINGH):

(a) to (c) Yes, Sir, the Government of Brazil had gifted a plot of land to the Government of India in 1965 for construction of an Embassy complex. The Government had initiated steps at various points of time for undertaking construction project including engagement of an architect for conceptual layout plan and for determination of estimated cost of construction. The economic viability of the project is yet to be established. The main reason being high cost of construction prevailing in Brazil compared with relatively lower rental structure. The cost of construction in Brazil at US \$1,000 per sq. meter is extremely exorbitant, whereas in most of the other countries the cost of construction is in the range of US \$ 400-500 per sq. meter.

(d) The rental paid in Brazil in the past 20 years works out to Rs. 11.2 crores. The Annual rental liability to the Government in respect of leased

buildings in Brazil is Rs. 1.18 crores as against the total annual rental liability on leased buildings in foreign countries of Rs. 142.16 crores.
