SHRI P. SHIV SHANKER (Gujarat): Mr. Chairman, Sir, with your kind permission, before Shri Sanjaya Sinh takes the oath, I would like to express our deep sense of resentment. condemnation and strong disapproval on his nomination to the Rajya Sabha by the Janata Dal Party and Prime Minister, whose relative happens to be. It is well known that he is facing a serious charge of murder on the dastardly killing of Shri Syed Modi. In selecting Shri Sanjay Singh as their nominee, the Janata Prime Minister Dal and the driven yet another nail into the coffin of the so-called value-based politics. This is indeed their issue-based politics, the politics of favouritism nepotism. There cannot be any objections before he takes oath. If any statement or a comment has been made while he is taking oath it must be expunged from the record. It cannot form part of the record. We will be setting a very unhealthy precedent. In that case every Member may have something to say against any hon. Member.

SHRI P. SHIV SHANKER: It has happened and there is no question of expunction. ... (Interruptions)...

THE MINISTER OF INFORMATION AND BROADCASTING AND PARLIAMENTARY AFFAIRS (SHRIP. UPENDRA): It is a question of election of an hon. Member. How can you allow this thing to go on record?

SHRI SUBRAMANIAN SWAMY (Uttar Pradesh): Just because he is from a poor Muslim family, his life has no value.
