SOME HON. MEMBERS : No, no ... *(Interruptions)*.. .

SHRI M. M. JACOB : Sir, we are not satisfied with the reply of the Minister. . . *(Interruptions)*.... We are not satisfied With the reply of the Minister. It is an unfortunate thing that he has not even complied with our request. Therefore, as a protest, we walk out.... *(Interruptions)*

KUMARI CHANDRIKA PREMJI KENIA (Maharashtra): Mr. Vice-Chairman, Sir, I want to make my Special Mention for which I have been waiting right from 5 o'clock.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR) : It is a Special Mention and, naturally, you have to wait.

SHRI SHANKAR DAYAL SINGH (Bihar) : Sir, I am on a point of order. I want to raise the issue of quorum now.

Whether it is Special mention or something else, there must be quorum. I wanted to raise the issue of quorum because there was no quorum. Now since the Members who went out are coming, there is quorum. Now, she can start her Special Mention.

KUMARI CHANDRIKA PREMJI KENIA : Sir, I take this opportunity to raise a very important and significant matter through my Special Mention on the last day of the current Session.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR) : But be brief. Go ahead.

KENIA : Sir, this is a very important issue.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR) : I appreciate it. Without addressing the Chair, you go ahead and finish quickly.

KUMARI CHANDRIKA PREMJI
KENIA : Sir, this is a very important issue. The long-awaited Report of the Acharya Ramamurthy Committee on Education, known as the Perspective Paper on Education v/as received yesterday. The Report will have a far-reaching effect on the social structure of the society, particularly on the younger generation. I feel that this policy document is as important as the Government announcement to implement some aspects of the Mandal Commission Report.

Sir, I would like to compliment and pay kudos to this Committee for envisaging a common school system. As the first step, it has recommended improvement in the quality of Government, local body and aided schools to make them effective instruments of social transformation. In fact, the plight of the Government schools as well as the local body schools is very deplorable. Proper grants are not given. For example, the Bombay Municipal Corporation gets only ten per cent.

THE VICE-CHAIRMAN (SHRI BHASKAR ANNAJI MASODKAR) : : Mr. Minister, please take note of what she is saying.

KUMARI CHANDRIKA PREMJI
KENIA : The Committee has taken a realistic approach by seeking universalisation of elementary education. A constitutional amendment, if needed, to make the right to education a fundamental right, has been proposed. Universalisation of education has been linked with the right to work.

The removal of regional disparities by developing learning resources in regional

languages vocationalisation of education from elementary level, opening up of schools for non-formal and adult education, providing for centre stage for teacher and local community for school education, developing institutional capabilities at local levels for standard setting agencies like UGC, NCERT, NIEPA, DIETS, etc. are some of the salient features of the perspective paper on education.

Mr. Vice-Chairman, Sir, the Report has pleaded for 6 per cent of GNP for Education. In 1986-87 it was only 3.9 per cent of the GNP. The main drawback of our educational system seems to be the resource crunch and low priority given to education at the time of budgetary allocation. The Government must provide 6 per cent GNP so as to provide a realistic approach to education.

The role of voluntary organisations and industry in making substantial financial contributions to education system needs to be emphasised. They can co-operate with the Government in making primary education spread in rural areas by constructing and maintaining school buildings, providing reading materials, running adult education centres, participating in school education and providing vocational education, etc.

The suggestions to scrap the Navodaya Vidyalayas is misconceived. The special schools for SC and ST and OBC children are required to make them integral part of society and merge them in the mainstream of the society.

Moreover, there is a need to highlight the aspect of national integration, Indian history, culture and traditions as the core of national curriculum. This aspect needs to be looked into and specific emphasis has to be laid on national integration in particular.

Finally, woman and drop-outs among girls has again been the neglected area. Special efforts should be made by the Government to spread education among women and girls.

Mr. Vice-Chairman, I am sure the Government will take into consideration these suggestions while finalising its education policy.
