

[The Deputy Chairman]

Mr. Jagesh Desai I request you, do not repeat. No senior Member I your stature should be repeating. I gave my ruling. I can't go beyond that. *(Interruptions.)* You do not hear. You are fond of hearing your own voice. At least allow me to say something *(Interruptions)*

SHRI N. K. P. SALVE (Maharashtra): Ma'am, the issue involved reversing the entire conventions of the House. Whenever a debate is taking place on an important issue and it is inconclusive, it is taken on the next day in Reference to the legislative business. It has happened all these years, I have seen; it has happened. About the Industrial Policy why are you going behind this precedent, this convention?

THE DEPUTY CHAIRMAN: I said, Mr. Salve, I will find out. I cannot give you the answer immediately. On any occasions it has happened in the past that the business has been changed; precedents have been changed. But in this case the business which was left over should have been listed And I assure you that in future it will not happen. Okay?

Now, can we go ahead? Prof. Chandresh P. Thakur. *(Interruptions)*

What is it? *(Interruptions)* I am happy that at least you are satisfied *(interruptions)*

#### RE GOVERNMENT'S LANGUAGE POLICY

SHRIMATI JAYANTHI NATARAJAN (Tamil Nadu): Madam, we wanted a statement from Government on the Bilingual policy. What has happened to ... *(Interruptions)*

SHRI PASUMPON THA. KIRUT-TINAN (Tamil Nadu): There will be no imposition of Hindi... *(Interruptions)* Hindi will not be imposed... *(Interruptions)*

SHRI V. NARAYANASAMY (Pondicherry): Hindi is being imposed in other States. *(Interruptions)*-

THE DEPUTY CHAIRMAN: He wants to say something. Let him say something. *(Interruptions)*

SHRI PASUMPON THA. KIRUT-TINAN: what is the reason for their repeating 1965? *(Interruptions)* No, there should be no imposition of Hindi. You are all responsible. The Congress is responsible. *(Interruptions)*

THE DEPUTY CHAIRMAN: In this cross fire you cannot speak. Let this cross fire be over. *(Interruptions)* Order please. The Minister wants to say something. Mr. Dipen Ghosh, please, take your seat.

THE MINISTER OF SURFACE TRANSPORT (SHRI K. P. UNNIKRISHNAN): On behalf of this Government I wish to say that the language policy of the National Front is very clear and unambiguous.

SHRI M. M. JACOB (Kerala): Madam, I am on a point of order.

THE DEPUTY CHAIRMAN: No point of order, Mr. Jacob. Please take your seat.

SHRI V. NARAYANASAMY: The Member can raise his point of order and the Minister has to yield.

THE DEPUTY CHAIRMAN: Please don't make it an issue. Please sit down. I have not permitted him. Point of order does not mean this becomes his birth-right.

SHRI V. NARAYANASAMY: Yes, it is

THE DEPUTY CHAIRMAN: It is not.

SHRI V. NARAYANASAMY: Under the rules it is his right.

The DEPUTY CHAIRMAN: See the rules book first.

SHRI V. NARAYANASAMY: He can raise it. You may rule it out.

THE DEPUTY CHAIRMAN: Take your saat.

SHRI K. P. UNNIKRIISHNAN: I will only quote from the National Front Manifesto, which is our policy. I quote:

"Use of regional languages in administration at State level and in education at all levels shall be promoted. Pandit Jawaharlal Nehru's assurance regarding the language policy will be implemented and all efforts would be made to promote the Indian languages. (*Interruptions*)

THE DEPUTY CHAIRMAN: Please speak through the mike.

SHRI K. P. UNNIKRIISHNAN: Gujral Committee's recommendation on Urdu will be implemented. The Schedule VIII will be extended to respond to the urges of other linguistic groups."

This is very clear and categorical and I wish to reiterate that this is the policy and we have no other policy.

SHRI M. M. JACOB: Madam, my point of order is this.

SHRI H. HANUMANTHAPPA (Karnfa'taka): Madam\_ I have not heard the Minister.

THE DEPUTY CHAIRMAN: Everybody was making noise. You want the Minister to repeat again?

SHRI H. HANUMANTHAPPA: Yes.

THE DEPUTY CHAIRMAN: O.K. The Minister may repeat.

SHRI M. M. JACOB: Madam, have you allowed me to raise the point of order?

THE DEPUTY CHAIRMAN: The Member wants him to repeat, i will allow you. (*Interruptions*) Pltase, let the Minister be heard.

SEVERAL HON. MEMBERS: We have heard him.

THE DEPUTY CHAIRMAN: No, one Member has not heard him. Have you heard him? He has not heard him. Now please let him hear. I have to protect every Member. (*Interruptions!*)

THE DEPUTY CHAIRMAN: Have you heard it?

SHRI H. HANUMANTHAPPA: Yes.

THE DEPUTY CHAIRMAN: Now, Mr. Jacob. You want to raise something.

SHRI M. M. JACOB: j. appreciate my good friend the hon. Minister, Shri Unnikrishnan, standing up and replying, but my point of order is this. Yeserday, in this House Mr. Upendra was categorically mention ing that he will censor anything in a Minister's speech which is other than his own Ministry. The Railway Minister's speech was censored by Mr. Upendra saying that that portion did not pertain to the Railway Ministry. So, my question is\_ has Mr. Unni krishnan been authorised to say this by the Prime Minister? We want a categorical assurance in this House. In this context there is a lacuna. Mr. Upendra mentioned yesterday that a Minister cannot speak on anything other than his own Ministry. (*Ittrter-rwptions*).

THE DEPUTY CHAIRMAN: Please let me deal with his point of order. Mr. Upendra is not in the Chair. In this House, what the Chair does counts, whoever is in the Chair. The Chair only can censor anything. It is not the Doordarshan or the 'Khula Manch.' This is Parliament of India where the Chair decides who will speak what. ....

SHRIMATI JAYANTHI NATARA-JAN; Madam, I want to ask... *(Interruptions)*.

THE DEPUTY CHAIRMAN; What is this? He wants to say something. Let her finish. Don't have atrocities on her. *(Interruptions)*.

SHRI PASUMPON THA. KIRUT-TINAN: Our hon. Minister has already replied on the language issue. This National Front's manifesto is clear, *(Interruptions)*. There will be no imposition at all. We will straightway fight for \_\_\_\_\_ *(Interruptions)*. And we will fight against Hindi imperialism. *(Interruptions)*

THE DEPUTY CHAIRMAN; I have heard you. Please.

SHRI PASUMPON THA. KIRUT-TINAN: They want to take political advantage of it. *(Interruptions)*. I want to know whether Rajiv Gandhi is prepared on this language ----- *(In. interruptions)*. Let them say whether they are prepared for a Constitution amendment on this language issue. *(Interruptions)*.

SHRIMATI JAYANTHI NATARA-JAN Madam, they are speaking without your permission. It should not go on record.

SHRI V. NARAYANASAMY: Mr. Unnikrishnan said that the three-language formula... *(Interruptions)* when the Chief Ministers of Janata Dal have decided \_\_\_\_\_ *(Interruptions)*.

SHRI PASUMPON THA. KIRUT-TINAN: Mr. Bakthavatsalam was responsible. Her grandfather was responsible.... *(Interruptions)*.

THE DEPUTY CHAIRMAN; Please don't bring in people's grandfathers.

SHRIMATI JAYANTHI NATARA-JAN; Madam, Mr. Unnikrishnan has responded. I appreciate what he said. I want to know this. If this is the stand of the Janata Dal, if this is the Stand of the National Front manifesto,

what action are they taking against their own Chief Ministers who have come out publicly? Have they passed any resolution?... *(Interruptions)*. Madam, it is very unfortunate that the DMK people are also supporting .... *(Interruptions)*.

SHRI S. JAIPAL REDDY (Andhra Pradesh): Madam,... *(Interruptions)* ■

THE DEPUTY CHAIRMAN: On the same issue? *(Interruptions)*.

SHRI V. NARAYANASAMY: Madam Deputy Chairman, for the sake of continuing in the Cabinet, the DMK is ----- *(Interruptions)* imposing Hindi on southern States. The point raised by us is whether they will take action against the Chief Ministers who passed resolutions.

SHRIMATI JAYANTHI NATARA-JAN: Madam, it is very strange how DMK is supporting Hindi.

SEVERAL HON. MEMBERS: No, no. *(Interruptions)*.

THE DEPUTY CHAIRMAN: Hon. Members, take your seats. We have had enough discussion on Hindi, English and any other language. Now please sit down.... Nothing should be spoken on this matter \_\_\_\_\_ It is over

SHRI V. NARAYANASAMY: As a protest, I walk out.

THE DEPUTY CHAIRMAN: You could have done that without making so much noise. Yes, Mr. Vishvjit Singh, you speak.

SHRI VISHVJIT P. SINGH (Maharashtra) : Madam, .... (*Interruptions*)

THE DEPUTY CHAIRMAN: The Hindi-English controversy is over. I **have identified someone else. That** matter is now closed. It is over. Mr. Unnikrishnan spoke on behalf of Government. The matter is over. They complained and put their grievances in the House whichever way they could. It is all right. Now I have called him.

SHRI VISHVJIT P. SINGH: Madam, I am sure the entire House will agree with me that the office of the Prime Minister of India is sacrosanct and due respect must be shown to the office of the Prime Minister of this country. This is a great country with a long history. It has wonderful future.

SHRI KAMAL MORARKA (Rajasthan). Carry on without any preamble.

### Recent Developments in Eastern Europe

PROF. CHANDRESH P. THAKUR (Bihar): Madam, Europe is undergoing; unprecedented changes and particularly, in eastern Europe the rate of change has been very rapid. Until recently we were mentally prepared that the European Economic Community will get consolidated economically by 1992 and following that there will be political consolidation of western Europe. Much before the process of political unification of western Europe could gather momentum, events in eastern Europe have overtaken it.

I was recently on a European trip and I had an opportunity for the first time to make contact with people who are observing developments and are
