THE DEPUTY CHAIRMAN: Now, it is over.

SHRI NARAYAN KAR: No, Madam - (Interruptions)

The entire country will be shocked to hear that 'during the last 29 months more than 200 women have been raped. FIRs have been lodged and the accused have been named, but not a single accused has been arrested and not a single case has been pursued. What is worse is that no protection is being provided to the women. The hoodlums have a free hand and the victims are totally helpless.

THE DEPUTY CHAIRMAN: Now. Mr. Kar.

SHRI NARAYAN KAR: He has been threatened with dire consequences in the court room itself if the bail in a particular case was not allowed. He was helpless, as his request to the police to arrest the culprits was not acceded to and he writes that he gave his judgment under duress. No action was taken by the Government in this case.

I request the Central Government to institute a CBI inquiry.

THE DEPUTY CHAIRMAN; Okay.

SHRI NARAYAN KAR: Law and order has completely broken down in the State and the entire Opposition today "has been completely thrown at the mercy of a handful of armed anti-socials, roaming throughout the State under the protection of Ministers.

Difficulties being faced by the Fishing Infiustryln Andhra Pradesh

SHRI MENTAY PADMANA-BHAM (Andhra Pradesh): Madam, I want to bring to the notice of the House a very important segment of our industry which is being put to a lot of pjoblems because of lack of

coordination between the Ministry of Food Processing and the Ministry of Finance.

Madam, the deep-sea fishing industry is one of the very important industries. It has made substantial contribution to the export sector ^ilso, in addition to the other Central revenues. What is required is re-schedulement of loans and waiver of interest. The industry Has been in crisis for the last four years. The artificially high price of oil in India as compared to overseas is one major factor which has made this industry sick. The Finance Ministry aiso removed a small concession last year by withdrawing the 50 per cent Central Excise concession on diesel/oils supplied to trawlers. (*Time Bell rines*)

This kind of negative action has ruined the fishing industry.

Most of the small entrepreneurs have received unfair treatment at the hands of the SCICI, that is, Shipping Credit and Investment Corporation of India, of the Banking Department. They have been faced with a "take it or leave it" attitude. Trie terms and conditions imposed by SCICI are such that it cannot be "called as rehabilitation, and on this pretext the SCICI is saying that entrepreneurs are not interested in rehabilitation in this industry, which is far from facts. And the SCICI is indulging in browbeating the entrepreneurs. VTime Bell rings)

The Government should summon various concerned departments and entrepreneurs to Delhi immediately and try to sort out this problem. The SCICI are imposing conditions which are not relevant. They want personal guarantee for old loans with regard to the rehabilitation programme which has been recently introduced. ___ They are now demanding that the entrepreneur should give a personal guarantee for the loans they have" already taken and also a percentage in the gross catch. It is very very difficult for the entrepreneurs to comply with
