People or, as the case may be, the Legislative Assembly of the State", wherever they occur, the words "each House of Parliament or, as the case may be, the Legislature, of the State" shall be subtituted.".

3. I am, therefore, to return herewith the said Bill in accordance with the provisions of rule 101 of the Rules of Procedure and Conduct of Business in Lok Sabha with the request that the concurrence of Rajya Sabha to the said amendment be communicated to Lok Sabha."

Madam, I lay a copy of the Bill as amended on the Table.

RE. BUSINESS OF HOUSE

THE DEPUTY CHAIRMAN. I have allowed Mr. Jagesh Desai. He is on his bgs. I will allow you.

SHRIJAGESH DESAI (Maharasshtra): For the last three days I have been demanding that the reply to the debate on the rising prices be given. Yesterday also I pointed out that this should be done. Today also this item is missing from the revised List of Business. The price of sugar has gone up to Rs. 15'-per kg. today. I demand that this should be taken up immediately after the discussion is over. But I am sorry that it is missing from the revised List of Business.

THE DEPUTY CHAIRMAN: I will find out from the Secretariat and let the House know. Now, the Constitution (Amendment) Bill.....(Interruptions)

DR. G. VIJAYA MOHAN REDDY (Andhra Pradesh): Madam, the Agriculture Minister was to come forward with a statement on the devastation that has taken place in Andhra Pradesh. It has not been listed in the business today. We have been reminding about it everyday. Today is the last day and the Minister must come forward for discussion on it. Madam, the situation is very grave in Andhra Pradesh. People are suffering. About the relief that has been given, the people are coming out...

DR. YELAMANCHILI SIVAJI (Andhra Pradesh): The Statement on Andhra Pradesh was listed the other day. The Minister did not make the statement and we were denied the right to ask clarifications.

THE DEPUTY CHAIRMAN: The Minister for Parliamentary Affairs wants to say something.

SHRI N. E. BALARAM (Kerala): Yesterday, the Minister of Finance was here to give the reply. I would request the hon. Chair to ask the Minister to give a reply today because the situation is very bad.

SHRIN. K. P. SALVE (Maharashtra): Madam, today the most burning question in the country is the price rise. Nothing should have been more important for this Government than to come before the House. (Interruptions) Madam, I want to make one thing absolutely clear. So far as we are concerned...

SHRI MENTAY PADMANA-BHAM (Andhra Pradesh): We have been pressing for this discussion for the last four or five days.

SHRIN. K.P. SALVE: Madam, it is very unfair to impute as though we are not interested. We are exceedingly interested. Yesterday, all that I said... (Interruptions) Yesterday, I conceded him the right to speak before me. Do you know this? Do we do that if we don't think that it is important, It is very important.

[Shri N.K.P. Salve]

Madam, it is not a question of your trying to find out from the Secretary-General. It is very kind of you to have said that. But the crucial question is what the Government is doing about it. If they had extended the House by two days, one question that should have come ahead of everything else was the price rise. If the Minister had to go somewhere, I have no objection. Let him go. But is he the only Minister? There is the other Minister in the Finance Ministry. He could have come and dealt with the matter and we could have asked him the questions. Madam, we are here in this House representing the rights and the interests of the people. It is the singular failure which has been foisted on us not to be able to ask questions on an important issue like price rise. I condemn the attitude of the Government. (Interruptions) It is highly reprehensible that they have denied this House the right to listen to what the Finance Minister has to say on price rise.

(Interruptions)

SHRI DIPEN GHOSH (West Bengal): Madam, you will kindly remember that the Short Duration Discussion on price rise was admitted oy the Chairman, it was admitted in all seriouseness and we, various Members of various parties and groups, had participated in it. It is not because of the fact that we wanted to discuss certain issues. It is because of the fact that we wanted the Government to take effective steps to control prices or to bring down prices. We have been eagerly awaiting to hear the Union Finance Minister's reply to our discussion. In fact, it was being listed every day. The Minister of Finance was also present but he could not reply. Today is the last day. So, we must know what excactly the Government has proposed to do or has got to do to control the prices. This is one aspect. The second aspect is that our Minister, Mr. Nitish Kumar, had made a statement on the devasta-Andhra Pradesh..... tion in

SHRI MENTAY PADAMAN-BHAM: He has not made the statement.

SHRI DIPEN GHOSH: Just listen.

THE DEPUTY CHAIRMAN: He placed it on the Table of the House.

SHRI DIPEN GHOSH: That is why I said that. He laid it on the Table of the house. The copy was circulated. But the point is that the House was adjourned on certain other issues. The House wanted that the clarifications be sought the next day and the minister should reply to the clarifications. But that 'next day' did not come because of other busiuess. So, that is also important. Today is the last day of the Session. So, my suggestion is that after the Constitution Amendment Bill is taken up and adopted, let the price rise reply be there first and then the clarifica tions be sought and replied to on thecyclone devastaion in Andhra Pradesh.

DR. JINENDRA KUMAR JAIN (Madhya Pradesh): Madam, I also wish to bring to the attention of the House and wish to point out another grave error on the part of this Government. They deserve condemnation on this account. That is the question of providing Statedhood to Delhi. Everybody knows that there is no water in many areas of Delhi today, there is no electricity in many areas of Delhi today, and there are a lot of problems.

SHRI H. HANUMANTHAPPA (Karnataka): We did not have water in the residences of the MPs. Madam, I did not have water today even to take bath. There was no water.

DR. JINENDRA KUMAR JAIN: The citizens of Delhi...

SHRI H. HANUMANTHAPPA: I live in Pandara Road. There was no water in my house.

DR. JINENDRA KUMAR JAIN: The citizens of Delhi have enormous problems. All of them are not as privileged as my friend, Mr. Hanumanthappa, who can come here and tell that he could not take bath because there was no water. People are suffering....

SHRI H. HANUMANTHAPPA: 1 am supporting you.

DR. JINENDRA KUMAR JAIN: 1 appreciate that.

SHRI H. HANUMANTHAPPA: There was no water to take bath today. This is the state of affair here under this Government. Even they cannot protect the Members of Parliament halo. We came all the way from our place, and we have to beg have for water to take bath. This is the efficiency of this Government.

DR. JINENDRA KUMAR JAIN: I am speaking for those who are the citizens of Delhi and they are being denied their democratic rights. And this Government has been doing things which amount to the cheating of the people. ... (Interruptions)

THE DEPUTY CHAIRMAN: He is on his legs.

SHRI SURESH KALMADI (Maharashtra): Withdraw your support.

DR. JINENDRA KUMAR JAIN: Don't suggest me action. Madam, what I am trying to say is, what this Government is doing amounts to the cheating by th. Government of the people of Delhi and all the Parties that have been supporting themin good faith. I wish to warn the Government that they should not take the Parties supporting them for granted. And I want to warn the Government not to take the people of Delhi for granted. (Interruptions) Let mespeak. Madam, I wish to remind this Government that they should look into the manifestos which were released not only by Ianata Dal, but also by the National Front. I wish to remind everybody that all major Parties sitting here had mentioned this, and this was the promise given to the people of Delhi that Delhi Statehood will be provided as early as possible.....

SHRI ATAL BIHARI VAJPA-YEE: Including the Congress Party.

DR. JINENDRA KUMAR JAIN: ...including the Congress Party. But this is not the only issue. The issue is the democratic rights of the people of Delhi which are being denied

SHRI V. NARAYANASAMY: You were in power in 1977. What were you doing?

DR. JINENDRA KUMAR JAIN: What is your problem?

SHRI V. NARAYANASAMY: You talk to the Chair. You address the Chair. (Interruptions)

THE DEPUTY CHAIRMAN: Please sit down.

SHRI V. NARAYANASAMY: You were in power in 1977. What have you done?

THE DEPUTY CHAIRMAN: Please take your seat. He is addressing me. You have no right to interrupt him.

SHRI V. NARAYANASAMY: Why is he shouting?

THE DEPUTY CHAIRMAN: Because you interrupted him without my permission. Mr. Narayanasamy, please sit down. You cannot interrupt him without my permission. (Interruptions) Please sit down.

NARAYANASA-V. MY: What did they do in 1977 when they were in the Government!

THE DEPUTY CHAIRMAN: You cannot interrupt anybody with. out my permission.

SHRI V. NARAYANASAMY: I was reacting.

THE DEPUTY CHAIRMAN: You cannot react.

DR. JINENDRA KUMAR JAIN: I urge upon the Government of India to keep the promises they made to the people. I urge upon the Government to keep in mind the sufferings of the people. I urge upon the Government to provide democratic rights to the people of Delhi and bring forward a properly-drafted legislation—there should be no excuses—to provide full Statehood to Delhi so that the people can have what they deserve. Thank you, Madam.

THE DEPUTY CHAIRMAN: Hon. Minister please. (Interruptions)

THE MINISTER OF INFOR-MATION AND BROADCAS-

TING AND PARLIAMENTARY AFFAIRS (SHRI P. UPENDRA): Madam, several demands have been made by hon. Members in regard to various issues. I do agree that replies are due on the discussion on price rise and on the statement on the cyclone in Andhra Pradesh. In fact, they were listed. The one, namely, the reply to the debate on price rise, was listed. Madam, the Government is prepared to accept the demand of the hon. Members.

of House

SHRI ATAL BIHARI VAJ-PAYEE: Why was this item taken out?

SHRI P. UPENDRA: We can have the reply to the debate on the price rise and also clarifications on the statement made by the hon. Minister of State for Agriculture regarding the cyclone in Andhra Pradesh. I will make a very concrete suggestion. We have provided three hours for the Constitution (Sixty-sixth Amendment) the House agrees, we will reduce it to two hours.

HON. MEMBERS: SOME No.

SHRI P. UPENDRA: Government is also prepared to postpone items 4 and 5 on the agenda, namely, the Legal Services Authorities (Amendment) Hire-Purchase 1990, and the (Amendment) Bill, 1989, to the next Session.

THE DEPUTY CHAIRMAN: Which items do you want to be postponed?

SHRI P. UPENDRA: Items 4 and 5. We can postpone them to the next Session. My suggestion is that we can take up items 1, 2 and 3, the Constitution (Sixty-sixth Amendment) Bill, the Salaries and Allowances of Officers of Parliament (Amendment) Emoluments and the President's

Pension (Amendment) Bill. After, wards, you can decide the order in regard to the reply to the debate on price rise, the half-an-hour discussion and clarifications on the statement on the cyclone in Andhra Pradesh. These three things can be taken up one after another after these three Bills are passed.

Now. Dr. Jain raised the issue about Statehood for Delhi. He was legitimately concerned about it. Similar concern was expressed in the Lok Sabha also yesterday when the Bill was introduced. Because of lack of time, all the parties in the House agreed that this measure may be postponed to the next sess-I assure hon. Members that this Bill, along with the other pending Bills for consideration, like the Lok Pal Bill, the Prasar Bharati Bill, the Bill on National Commission for Women...

DR. JINENDRA KUMAR JAIN: It should be a properlydrafted Bill, granting full Statehood for Delhi.

SHRI Ρ. UPENDRA: Full Statehood for Delhi. (Interruptions) Everything will be provided. Allt hese pending Bills—the Bill providing for full Statehood for Delhi, the Lok Pal Bill, the Prasar Bharati Bill, the Bill on National Commission for Women-of course, the Bill providing for the establishment of Legislative Councils in Tamil Nadu and Andhra Pradesh has already been passed by this House, but it is pending in the other House together with the Bills which have been introduced in the other House and in this House like the Bill on electoral reforms, the Bill providing for workers' participation in management and the Bill on the setting up of a National Judicial Commission, will be listed for the next Session commencing in the first week of August. I assure hon. Members that the Bill providing for full Statehood for Delhi, the Lok Pal Bill and the Parasar Bharati Bill will be listed in the first week itself.

THE DEPUTY CHAIRMAN: Now, we go to the next item. (Interruptions)

SHRI H. HANUMANTHAP-PA: Madam, I want to raise a matter of injustice to the House. (Interruptions)

MARGARET SHRIMATI (Karnataka): Madam, I want to raise one important issue. It is now clear that Mr. Ramakrishna Hegde gave instructions to the Karnataka Chief Secretary for tapping the telephones. come out in the report laid on the Table of the House. SHRI M. M. JACOB (Kerala); Are we adjourning for lunch or not? Today is Friday.

THE DEPUTY CHAIRMAN: I am in the hands of the House. I do not want to take any decision arbitrarily. I want the Members to decide. If they want the lunch hour, we will adjourn and if they do not want the lunch hour, it is for them to decide. (Interruptions). Please.

SHRI RAFIQUE ALAM (Bihar): Every time on Friday we get lunch break. Otherwise, we won't be able to participate in discussions.

Friday has traditionally been a day when we have a longer lunch hour, but today, as Shri Salve has rightly pointed out, price rise and other important matters are pending. I request the Members to go for lunch or namaz turn by turn. Why should we adjourn for lunch? Let them go turn by turn. (Interruptions). We can finish this Constitution Amendment Bill by 2.00.

THE DEPUTY CHAIRMAN: I do not want to take any responsibility. Whatever the House decides, I will do that.

SHRI DIPEN GHOSH: As far as I 'mow namaz has certain specified time. Even if we skip the lunch period, the voting time must not be kept at the time when there is a prayer. Even if we skip the lunch hour, the Members can go for prayers turn by turn but the voting time has to be fixed keeping in view what exactly the prayer time is. (Interruptions).

SHRI N. K. P. SALVE: By 2.30 we can finish.

THE DEPUTY CHAIRMAN: So, at 2.30 we will have the voting. Then we will have Half-an-Hour Discussion, Mr. Salve, and then clarifications on steel. And the price rise. (Interruptions). It is not listed today. We will take it up.

THE DEPUTY CHAIRMAN: We will pass the Bills without discussion.
