- (b) whether the proposed 200 drugs which will come under price control are from amongst the list of about 250 essential drugs prepared by World Health Organisation;
- (c) whether the price control will cut the profit margin of manufacturers and traders, who in turn are likely to cut or stop production of these essential drugs; and
- (d) if so, what specific steps are proposed to be taken to deal with the problem and by when the new policy is likely to come into force?

THE MINISTER OF PETRO-LEUM AND CHEMICALS (SHRI M. S. GURUPADASWAMY): (a) to (d) Government has decided to review the 1986 Drug Policy with the objectives of increasing the indigenous production of drugs encouraging fresh investments and giving reasonable return to the industry, as well as to make quality medicines easily available to the consumers at reasonable prices. The process of review is on.

- (d) if so, when and if not, what steps have been taken to expedite the matter?

THE MINISTER OF PETRO-LEUM AND CHEMICALS (SHRI M. S. GURUPADASWAMY): (a) to (d) The requisite information has already been finished in reply to Rajya Sabha Unstarred Question No. 2187 answered on 27-8-1990.

Price approval by importers of formulations

2945. SHRI ASHOK NATH VER-MA: CHOWDHARY RAM SE-WAK:

Will the Minister of PETRO-LEUM AND CHEMICALS be pleased to refer to the answer to Unstarred Questton 901 given in the Rajya Sabha on the 16th August, 1990 and state:

- (a) whether it is a fact that all imported formulations based on drugs not included under Schedules I and II are exempted from price control irrespective of sales turnover;
- (b) whether it is a fact that none of the importers of medicines have applied for price approval under DPCO, 1987;
- (c) what is the total number of applications received by his Ministry for fixation of prices for imported formulations under DPCO, 1987 and in how many cases prices were fixed;
- (d) whether it is a fact that importers are charging very high prices for their formulations; and

(e) what steps have been taken to safeguard the interest of poor consumer?

THE MINISTER OF PETRO-LEUM AND CHEMICALS (SHRI M. S. GURUPADASWAMY): (a) Yes, Sir.

- (b) No, Sir. Importers of finished formulations which are covered under **DPCO** 1987 have applied for price approval.
- (c) Fixation of prices is a continuing process. The exact number of imported formulations where the prices have been fixed by the Govt. under DPCO, 1987, is not readily available. However, during the last one year, Government have fixed the prices of about 121 imported formulations.
- (d) and (e) The prices of imported formulations are to be fixed giving MAPE of 50% on the landed cost in accordance with the provisions contained in the DPCO, 1987 and it is obligatory for the concerned parties to follow price. However, no instances of charging higher price in respect of imported finished formulations covered under DPCO, 1987, have come to the notice of the Government.

Duty concession to bulk drugs

2946. SHRI ASHOK NATH VER-MA: CHOWDHARY RAM SE-WAK:

THE MINISTER OF PETRO-LEUM AND CHEMICALS (SHRI M. S. GURUPADASWAMY): (a) and (b) The prices of Doxycycline have been reduced recently from Rs. 5456/- per kg. to Rs. 4968/per kg. inter-alia taking into consideration customs duty reduction in the intermediate. The price of Chloramphenicol Powder has gone up inspite of duty reduction on L-base. Action is already on to bring down the prices of formulations based on Diclofenac Sodium and other drugs based on duty concession granted in the past.
