# Revised Estimates submitted by DESU to Delhi Municipal Corporation

2920. SHRI G. Y. KRISHNAN: Will the Minister of ENERGY be pleased to state:

- (a) whether it is a fact that the Delhi Electric Supply Undertaking has submitted the revised estimates to the Delhi Municipal Corporation for street lighting works on the approach road to the DDA MIG flats complex in Block-A, Friends Colony, East;
- (b) if so, what are the details thereof;
- (c) whether Delhi Municipal Corporation has made the necessary payments;
- (d) if not, what are the reasons therefor; and
- (e) what steps have been taken by Government to ensure execution of the street lighting work by DESU without further delay?

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIF MOHD. KHAN): (a) to (e): According to the DESU, a revised estimate of Rs. 24, 382/- for improvement of the the existing street lighting and pro-

viding additional street lighting points in the said area was sent to the Municipal Corporation of Delhi in September, 1989. The MCD has since decided to release the requisite payment to the DESU for execution of the work.

#### Power Break Down in East Friends Colony

- 2921. SNRI G. Y. KRISHNAN: Will the Minister of ENERGY be pleased to state:
- (a) whether there has been frequent break-down of power supply to the DDA MIG Flats in Block-A, Friends Colony East, New Delhi;
- (b) if so, what are the reasons therefor;
- (c) whether the proosed 11 KV HT system has improved electric supply to that colony; and
- (d) if not, what further steps would be taken by DESU to ensure continuous power supply to this Colony?

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIF MOHD. KHAN): (a) to (d): According to the DESU, the power supply position

in the said colony is satisfactory. As such no further augmentation of the 11 KV system is contemplated for this area at present, except routine maintenance which is carried out regularly.

### **Restoration of flights**

- 2922. SHRIMATI MIRA DAS: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whethr Orissa Government has requested for the restoration of certain flights withdrawn w. e. f. 5-3-1990;
- (b) if so, what are the details threof:
- (c) what are the reasons for withdrawing these flights; and
- (d) whether Government propose to restore these flights; if not, what are the reasons therefor?

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIFMOHD. KHAN): (a) and (b) Yes, Sir. Government of Orissa has requested to restore the seven curtailed services operated by Indian Airlines.

- (c) Due to suspension of A-320 aircraft services, return of B-737 aircraft taken on lease and re deployment of available aircraft capacity on some of the A320 routes the services on many sectors throughut the Indian Airlines' network were curtailed/withdrawn. Vayudoot operations to Bhubaneswar and Jaypore have been sus pended since September 1989 conse quent to the loss of Doriner air craft in Pune aircrash and poor oad factor.
- (d) Indian Airlines would re store the curtailed / withdrawn flights after the A-320 aircraft are deployed for operations of sche duled services. Vayudoot has no

immediate plans to restor; operations to Bhubaneswar and Jypore in view of shortage of aircraft capacity and poor load factor.

#### Restoration of Vaydoot services from Bbubaneshwar-Jeypore-Vizag sector

- 2923. SHRIMATI MIRA DAS: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether there has been persistent demand for the restoration of Vayudoot services withdrawn from Bhubaneshwar-Jeypore-Vizag sector since September, 1989;
- (b) whether there is also a demand to include Bhubneshwar which was excluded in December, 1986 from the Bhubneshwar-Rourkela-Calcutta sector and which is at present limited only to Calcutta and Rourkela;
