been allowed the benefit of revision of the scales of pay as recommended by various Pay Commissions from time to time and, as made applicable to similarly placed other voluntary organisations; and

(b) if not, what steps Government contemplete to ensure that such staff, appointed for a national cause, gets, equal treatment in matter of pay with their counterparts in similar other voluntary organisations run Government's grant-in-aid, especially when the Association has committed in its service rules to protect the scales of pay of Government aided staff on each revision as per recommendations of Pay Commissions set up from time to time?

- (a) the number of court cases in which the Family Planning Associa tion of India, New Delhi Branch, has been engaged during the last 5 years, against its own employees, with break-up figures of the cases-

- (b) the amount spent on these litigations, including specification of fess paid to counsels, out of the

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RASHEED MASOOD): (a) According to information available from Family Planning Association of India (FPAI), New Delhi Branch, it has been engaged in eight such litigations, Out of these, two have been decidedone in favour of the Family Planning Association of India and in the remaining case, the court has ordered payment of one year's wages as terminal compensation. Initial stay granted in one case has since been vacated. Six cases are pending in the court.

- (b) As reported by the Delhi Administration, no amount has been spent on these litigations out of the grant-in-aid sanctioned to Family Planning Association of India. New Delhi Branch exclusively for family welfare programme.
- (c) Grant-in-aid paid to the institutions is subject to audit by Examiner Local Fund Accounts who sees that the amount is utilised execlusively for family welfare programme for which it is sanctioned.

Permission to issue liquor trading licences

2983. SHRI NYODEK YONG-GAM: Will the Minister of INDUS-TRY be pleased to state:

- (a) whether the Central Government have permitted the Government of Arunachal Pradesh to issue liquor trading licences in the State; and
- (b) if not, what are the reasons therefor?

THE MINISTER OF INDUSTRY (SHRI AJIT SINGH): (a) and (b) Purchase and sale of intoxicating liquors is a State subject as listed in the Seventh Schedule of the Constitution of India. No permission is re-quired to be issued to State Governments under the provisions of the Industries (Development & Regulation) Act 1951 for issue of liquor trading licences.
