क्या प्रधान मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या मध्य प्रदेश में व्यावसायिक शिक्षा के लिए धन का आवंटन किया जा रहा है ताकि राज्य में खोले गए नए स्कूलों में व्यावसायिक शिक्षा दी जा सके; और

(ख) यदि हाँ, तो इस संबंध में व्यौरा क्या है ?

मानव संसाधन विकास मंत्रालय में राज्य मंत्री (श्री चिमन भाई मेहता) : (क) और (ख) माध्यमिक शिक्षा के व्यावसायीकरण की केंद्रीय प्रायोजित योजना के अंतर्गत मध्य प्रदेश सरकार को 1069 व्यावसायिक पठ्यक्रम वाले 369 स्कूलों में +2 स्तर पर व्यावसायिक पठ्यक्रम शुरू करने के लिए वर्ष 1987-88, 88-89 तथा 89-90 के दौरान 1923.64 लाख रुपये की वित्तीय सहायता संस्वीकृत की गई। वर्ष 1990-91 के 1221.42 लाख रुपये की राशि मुक्त की जा रही है।

**Criteria for giving Selection Grade to MCD Teachers**

3109. SHRI RAMSINH RATHWA: Will the PRIME MINISTER be pleased to state:

(a) what is the criteria for giving selection grade to Primary and Nursery Teachers of Municipal Corporation of Delhi;

(b) whether selection grade to Nursery Teachers appointed in 1979 has not been given while the Primary Teachers appointed in 1980 have been given the said grade; and

(c) if so, the reasons for this discrimination and whether it is proposed to give selection grade to Nursery Teachers appointed in 1979 with retrospective effect?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI CHIMAN-BHAI MEHTA): (a) Selection grade to Primary and Nursery Teachers of Municipal Corporation of Delhi Schools is given to 20 per cent of the total posts according to the seniority list of Teachers.

(b) According to the information furnished by Municipal Corporation of Delhi, selection grade to Primary Teachers have been given covering the period upto 2-1-1962 and in case of Nursery Teachers upto 30-1-1970.

(c) There is no discrimination in granting the selection grade to Nursery Teachers.
