THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RASHEED MASOOD): (a) to (c) M|s. Parle Pro-ducts|Parle Beverages have informed the Ministry of Food Processing Industries that BVO is not nsed in manufacture of Gold Spot and Limca.

The Ministry of Food Processing Industries has issued instructions to their regional offices to inspect the stocks in the factory and in the market and to draw samples for the purpose of ensuring that these are free from BVO.

The Ministry of Health and Family Welfare issued instructions to the also StatesJU.Ts. to ensure that soft drinks marketed after 15-4-90 are free from BVO;

A's per information made available by Delhi Administration, 2 samples of Gold Spot and one sample of Limca manufactured by two bottling companies in Delhi have been found to contain BVO.
