The detailed programme has been worked out for implementation of Technology Development for Indian Languages (TDIL) during the VIII Plan period. This will be launched after the VIII Plan proposals have been approved. An amount of Rs. 17 crores is estimated for this programme during the VIII Plan but this is yet to be finalised. No amount has been spent so far.

Stoppage of bonus payment by IRE Limited, Chatupur. Orissa

3048. SHRI BASUDEB MOHAPAT-RA: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the management of IRE Limited, Chatupur in Orissa has stopped paying customary bonus from 1987-88 which was being paid to the workers since 1975, regularly; and

(b) if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY (PROF. M. G. K. MENON): (a) Yes, Sir.

(b) OSCOM Unit started commercial production in Oc'ober, 1986. During the construction phase (1975-86) the employees were paid customary The payment of Bonus Act bonus. became applicable from the accounting year 1987-88. Under Section 16 of the Payment of Bonus Act a unit has to pay bonus to its employees during the first five years, only if it makes profit. After first five years minimum bonus is payab'e even if it incurs loss. Since OSCOM incurred losses during the year 1987-88, 1988-89 and 1989-90, the employees are not entitled to any bonus for these years.
