trying to find out. Everbody is very anxious about her safety. You must take this responsibility and please see that she is safe.

Arrest of a Member

SHRI KAPIL VERMA: She might have been taken to another Police Station.

THE DEPUTY CHAIRMAN: Now we have a reply by the Finance Minister to the Short Duration Discussion and a Statement on Andhra Pradesh. Let the Finance Minister reply.

THE MINISTER OF FINANCE (PROF. MADHU DANDAVATE): Madam, I would suggest that in this atmosphere the Discussion on the price situation would not be all right. It may be put off till tomorrow.

SHRI P. SHIV SHANKER: Madam, that would be fine because it is a serious matter.

THE DEPUTY CHAIRMAN: If the House agrees...

SOME HON. MEMBERS: Yes, yes.

SHRI S. S. AHLUWALIA The Government is misleading the House. (Interruptions).

THE VICE-CHAIRMAN CHANDRESH P. THA-, (PROF. KUR): What do we do now?

SHRI P. SHIV SHANKER: We sit down. We would like to find out. We wait.

THE VICE - CHAIRMAN (PROF. CHANDRESH P. THA-KUR): I leave it to the Minister. The Finance Minister has offered that he will give his reply tomorrow. Mr. Minister, would you also like to follow him? The House is seriously exercised. There is absolute unanimity on this issue. Members are seriously concerned over the safety of the hon. Member. We appreciate the fact that the hon. Finance Minister has offered that he would not like to respond to the discussion on price rise, today, keeping in view the agitated mood of the House and the serious concern expressed by hon. Members. believe, the Minister of State for Agriculture is also following suit and he is associating himself with the sentiments of the House. Now, the official Business has been sought not to be further pursued. House is not in a mood to do anything else, other than finding out the position in R gard to Kumari Sushila Tiria. What do we do at this stage? What is the pleasure of the House?

SHRI P. SHIV SHANKER: We will sit here. We will await the information.

THE VICE-CHAIRMAN (PROF. CHANDRESH P. THA-KUR): It is a very serious situa-tion. The Minister has said. The Home Minister has shared the information which he had. also shared his exasperation. Let us be fair to the Home Minister. He shared whatever information he had. He also shared his own anguish in regard to the state of functioning of his Department to the extent that he is not prepared to accept the information which had been given to him twice. trying to locate Kumari Sushila Tiria. He is trying to collect some additional information, to with the House. Let us co-operate. Let us have patience. Of course, it is a very anomalous situation. The House is sitting, but there is no official Business. The Members are not interested in listening to anything. I am not sure what I should do as Vice-Chairman.

SHRI S. S. AHLUWALIA: We should sit and pray to God about the fate of the country.

VICE-CHAIRMAN THE (PROF. CHANDRESH P. THA-KUR): We only hope that the lady is safe and that she has not subjected to any physical harassment or torture. We would like to be assured only by her. and directly by her, that nothing untoward has happened so far as her person is concerned. I am sure, the Government will take u pon itself the responsibility to satisfy to the full, every Member of this House, that the Member's respect has not been compromised in any manner, even in a marginal way.

SHRI DIPEN GHOSH: Sir, I only want to draw your attention that the matter has already been referred to the Privileges Committee. tee. Whatever statement the Police

Commissioner has given, if there is any deviation or departure from that statement, if anything happens in the meantime, that also forms part of the Privileges Committee. The senior Minister is here. He will take note of it. He will take care of it. We can leave it to the Government to take care. Otherwise, the Government will also be criticised. Now, for the present, we can adjourn the House.

SHRI SITARAM KESRI: The Home Minister is in Parliament House, in some room. You please make enquiries and request him to come here immediately. (Interruptions).

SHRI DINESHBHAI TRIVEDI (Gujarat): Sir, you have permitted me. I am on my legs. (Interruptions). This is really a serious matter. We are equally concerned. I think we must have all the details as soon as possible, but we must keep in mind one thing that the Police Commissioner has gone on record as saying that the hon. ladv Member has been released. After she has been released she is a free bird. she can go anywhere she likes. She is under no vigilance and she cannot be forced that she must come immediately to the House. (Interruptions). She is under no vigilance. (Interruptions).

SHRI MADHU DANDAVATE: Why is there this vacuum? There is no rule. No business is being transacted. (Interruptions).

THE VICE-CHAIRMAN (PROF. CHANDRESH P. THAKUR): Please sit down. (Interruptions). Please sit down. Nothing will go on record.

THE VICE-CHAIRMAN (PROF. CHANDRESH P. THAKUR): The fate of a Member of this House is a concern of every Member of this House. There is no exception there. Now I am responding to the

hon. Member's comment that the police has reported that she has been released and that she is a free bird. (*Interruptions*). Why are you interrupting?

Unless somebody takes the responsibility and particularly in this case the Government, that she has been really released and she has been released safe, she is in this city at her own volition, the House is not prepared to accept the police version. The police has lost its credibility particularly in this case. (Interruptions). So far as the business of this House, keeping in view the agitated mood of the people, is oncerned....

Before they leave this House, before they leave this building, they must know the safety of the Member concerned. I suggest that either the Minister for Agriculture continues his statement, or the House can adjourn for half an hour and in the meantime the Home Minister can ascertain the facts and come and make a statement here.

SHRI P. SHIV SHANKER: The House should be adjourned for half an hour.

THE VICE-CHAIRMAN (PROF, CHANDRESH P. THAKUR): The House is adjourned for half an hour.
