Raising agency charges for National Highway works

3306. SHRIMATI MIRA DAS: Will the Minister of SURFACE TRANSPORT be pleased to state:

(a) whether the State Government of Orissa have asked Central Government

to raise the 9 per cent agency charges provided by the Centre, to 20 per cent for the execution of National Highway Works by N. H. Organisation in order to meet the expenditure towards establishment, pension and gratuity;

(b) if so, whether Government have agreed to the proposal made by the State Government of Orissa; and

(c) if not, the reasons therefor stating the extent to which the agency charges are proposed to be raised by the Government?

THE MINISTER OF SURFACE TRANSPORT (SHRI K. P. UNNKRI-SHAN): (a) to (c) There have been consistent demands from various State Governments, including the Government of Orissa, for enhancement of Agency Charges. These demands have been considered carefully from time to time including by a High Level Committee which had concluded that there was no Justification for any change in the existing rates as there had been steep increase in the price of input materials whereas the unit cost of supervision had not gone up in the same order.
